
A BILL FOR AN ACT

RELATING TO PHYSICAL EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that early instruction in
2 physical education is important to the long-term health of
3 Hawaii's citizenry. Contemporary physical education instruction
4 goes beyond playing games and learning the rules to promoting
5 and furthering the understanding of healthy physical activity
6 habits.

7 The purpose of this Act is to promote public school
8 students' long-term physical health.

9 SECTION 2. (a) With regard to public school education,
10 the department of education shall:

11 (1) Establish programs and activities that promote a
12 commitment to lifelong physical activity and decreased
13 sedentary behavior, including the development of
14 after-school and summer programs, which shall be
15 taught by licensed physical education teachers
16 beginning with the 2008-2009 school year;



1 (2) Define and implement a developmentally appropriate
2 course of study for physical education instruction in
3 grades kindergarten through six that is taught by at
4 least one licensed physical education teacher per
5 school by school year 2013-2014;

6 (3) Implement physical education instruction that is
7 generally in accordance with the standards established
8 by the National Association for Sports and Physical
9 Education as a core requirement for grades seven and
10 eight; and

11 (4) Develop and recommend to the board of education a
12 policy for the issuance of specialized credit for
13 participation in after-school athletic activity and
14 other co-curricular activities by school year 2009-
15 2010.

16 (b) The department of kinesiology and leisure at the
17 University of Hawaii, the department of education, and the
18 Hawaii teacher standards board shall work together to establish
19 and implement appropriate policies and programs to actively
20 recruit, train, and license physical education teachers.

21 SECTION 3. There is appropriated out of the general
22 revenues of the State of Hawaii the sum of \$ or so



1 much thereof as may be necessary for fiscal year 2008-2009 for
2 the establishment of after-school and summer programs and
3 activities that shall be taught by licensed physical education
4 teachers beginning with the 2008-2009 school year.

5 The sum appropriated shall be expended by the department of
6 education for the purposes of this Act.

7 SECTION 4. There is appropriated out of the general
8 revenues of the State of Hawaii the sum of \$65,000 or so much
9 thereof as may be necessary for fiscal year 2008-2009 for the
10 establishment and implementation of appropriate policies and
11 programs to actively recruit, train, and license physical
12 education teachers.

13 The sum appropriated shall be expended by the department of
14 education for the purposes of this Act.

15 SECTION 5. There is appropriated out of the general
16 revenues of the State of Hawaii the sum of \$65,000 or so much
17 thereof as may be necessary for fiscal year 2008-2009 for the
18 University of Hawaii, department of kinesiology and leisure, for
19 one additional faculty teaching position to increase the
20 University of Hawaii's capacity to recruit and retain licensed
21 physical education teachers.



1 The sum appropriated shall be expended by the University of
2 Hawaii for the purposes of this Act.

3 SECTION 6. This Act shall take effect upon its approval;
4 provided that sections 3, 4, and 5 shall take effect on July 1,
5 2008.

Description:

Requires the department of education to implement physical education instruction for grades kindergarten through eight; requires the department of education to develop and recommend to the board of education a policy for the issuance of specialized credit for certain athletic and co-curricular activities; provides for the recruitment of licensed physical education teachers; and makes appropriations.
