S.B. NO. 3144

A BILL FOR AN ACT

RELATING TO SOLID WASTE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that as the population of
2 Hawaii has grown in recent years, the amount of waste entering
3 the waste stream, and ultimately the Hawaii's landfills, has
4 increased as well. The legislature further finds that the
5 capacity for disposing of solid waste continues to diminish in
6 the State. With available landfill space running out in the
7 face of population growth and economic development, and few
8 options for acquiring more disposal space, it is important for
9 the State to re-assess its waste reduction goals.

10 Act 324, Session Laws of Hawaii, 1991, established
11 aggressive goals to reduce the solid waste stream by twenty-five
12 per cent by 1995 and by fifty per cent by 2000. In continuing
13 to address these concerns, the legislature finds that further
14 reductions in the waste stream are necessary to preserve the
15 sustainability of the State and its growth.

16 The purpose of this Act is to establish the goal of
17 reducing the solid waste stream in the State by seventy-five per
18 cent by 2012.



1 SECTION 2. Section 342G-3, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:

3 "(a) It is the goal of the State to reduce the solid waste
4 stream prior to disposal by:

5 (1) Twenty-five per cent by January 1, 1995; [~~and~~]

6 (2) Fifty per cent by January 1, 2000; and

7 (3) Seventy-five per cent by January 1, 2012;

8 through source reduction, recycling, and bioconversion. Where
9 feasible, the office shall establish other state goals for
10 specific commodities, recognizing market considerations.

11 No later than January 1, 2010, the counties shall
12 incorporate these goals into their revised integrated solid
13 waste management plans under part III.

14 The director shall adopt rules to provide appropriate
15 penalties for any county that fails to achieve these goals in a
16 timely manner."

17 SECTION 3. The department of health shall submit a report
18 to the legislature detailing past progress in solid waste
19 reduction in the State and future strategies and methods that
20 will assist the counties in meeting the solid waste reduction
21 goals in this Act, no later than twenty days prior to the
22 convening of the regular session of 2009.


