A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
ELEVENTH SENATORIAL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2008-2009:

5 1. Queen Kaahumanu school, Oahu

6 A. Build a computer resource center,
7 classrooms, and special education
8 support space

9 Plans, design, and construction \$1,980,000

10 2. Lincoln elementary school, Oahu

11 A. Complete the upgrade to the air-
12 conditioning project underway for
13 the classrooms and administration
14 building.

4 SECTION 2. The appropriations made for the capital
5 improvement projects authorized by this Act shall not lapse at
6 the end of the fiscal year for which the appropriations are
7 made; provided that all moneys from an appropriation
8 unencumbered as of June 30, 2010, shall lapse as of that date.

9 SECTION 3. The sums appropriated for the respective
10 capital projects set forth in section 1 shall be expended by the
11 department of education for the purposes of this Act.

12 SECTION 4. This Act shall take effect on July 1, 2008.
