A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the scope and level
2 of responsibilities of the board of education merits
3 compensation to its members based on a salary.

4 The purpose of this Act is to establish salaries for the
5 members of the board of education.

6 SECTION 2. Section 302A-1105, Hawaii Revised Statutes, is
7 amended to read as follows:

8 "§302A-1105 [~~Compensation;~~] Salaries; compensation;
9 expenses. (a) Board [~~of education]~~ members shall [~~be allowed;~~]
10 receive an annual salary.

11 (b) Effective July 1, 2007, the annual salary of the
12 chairperson of the board shall be \$ _____ and the annual
13 salary of all other board members shall be \$ _____.

14 (c) Any provision of law to the contrary notwithstanding,
15 all members of the board shall be included in any benefit
16 program generally applicable to officers and employees of the
17 State.



1 (d) Any provision of law to the contrary notwithstanding,
2 all members of the board shall be allowed:

3 (1) ~~[Compensation at the rate of \$100 per day for each~~
4 ~~day's actual attendance at meetings;~~

5 ~~{2}]~~ Transportation fares between islands and abroad; ~~[and~~

6 ~~{3}]~~ (2) Personal expenses at ~~[the]~~ rates specified by the
7 board while attending board meetings or while on
8 official business as authorized by the chairperson,
9 when the board meetings or official business require a
10 board member to leave the island upon which the board
11 member resides ~~[-]~~; and

12 (3) A protocol allowance to cover expenses incurred in the
13 course of a member's duties and responsibilities."

14 SECTION 3. There is appropriated out of the general
15 revenues of the State of Hawaii the sum of \$, or so
16 much thereof as may be necessary for fiscal year 2007-2008, and
17 the same sum, or so much thereof as may be necessary for fiscal
18 year 2008-2009, for the purposes of this Act.

19 The sums appropriated in this section shall be expended by
20 the department of education for the purposes of this Act.

21 SECTION 4. Statutory material to be repealed is bracketed
22 and stricken. New statutory material is underscored.



1 SECTION 5. This Act shall take upon its approval; provided
2 that section 3 shall take effect on July 1, 2007.
