# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to program planning,  
4 analysis, and budgeting (BUF 101) the following sums, or so much  
5 thereof as may be necessary, to fund for fiscal biennium 2007-  
6 2009 the Hawaii employer-union health benefits trust fund costs  
7 contained in the agreements negotiated with the exclusive  
8 bargaining representatives of collective bargaining units (2),  
9 (3), (4), (6), (8), (9), and (13):

12 SECTION 2. Funds appropriated or authorized by this part  
13 shall be allotted by the director of finance to the appropriate  
14 state departments for expenditure in each respective fiscal year  
15 for the purposes of this part.

1 SECTION 3. There are appropriated or authorized from the  
 2 sources of funding indicated below to program planning,  
 3 analysis, and budgeting (BUF 101) the following sums, or so much  
 4 thereof as may be necessary, to fund for fiscal biennium 2007-  
 5 2009 the Hawaii employer-union health benefits trust fund costs  
 6 authorized by chapter 89C, Hawaii Revised Statutes, for state  
 7 officers and employees in the executive branch who are excluded  
 8 from collective bargaining and belong to the same compensation  
 9 plans as those officers and employees within bargaining units  
 10 (2), (3), (4), (6), (8), (9), and (13):

13 SECTION 4. Funds appropriated or authorized by this part  
 14 shall be allotted by the director of finance to the appropriate  
 15 state departments for expenditure in each respective fiscal year  
 16 for the purposes of this part.

18 SECTION 5. The cost adjustments provided in this Act for  
 19 any officer or employee whose compensation is paid, in whole or  
 20 in part, from federal, special, or other funds shall be paid  
 21 wholly or proportionately, as the case may be, from the  
 22 respective funds.



1 SECTION 6. Funds appropriated or authorized by this Act  
2 that are not expended or encumbered by June 30, 2008, and  
3 June 30, 2009, of the respective fiscal years, shall lapse as of  
4 those dates.

5 SECTION 7. This Act shall take effect on July 1, 2007.
