Your Committee on Tourism & Culture, to which was referred
H.B. No. 1017 entitled:

"A BILL FOR AN ACT RELATING TO HAWAII TOURISM AUTHORITY,"

begs leave to report as follows:

The purpose of this bill is to provide Hawaii's tourism
workforce with a voice on the Board of Directors of the Hawaii
Tourism Authority (Board of HTA) by requiring that at least one
public, voting member of the Board of HTA represent local labor
organizations in the state.

UNITE HERE! Local 5 supported the intent of this bill. The
Hawaii Hotel & Lodging Association did not support this measure.
HTA opposed this bill.

Your Committee has amended this measure by changing its
effective date to January 1, 2025, to encourage further
discussion.

As affirmed by the record of votes of the members of your
Committee on Tourism & Culture that is attached to this report,
your Committee is in accord with the intent and purpose of H.B.
No. 1017, as amended herein, and recommends that it pass Second
Reading in the form attached hereto as H.B. No. 1017, H.D. 1, and
be referred to the Committee on Finance.


