H.B. No. 2172 was introduced as a short-form bill, which is

introduce a bill containing only a general idea as to the purpose

Your Committee has amended the bill to provide the  
substantive contents of the bill in long form so that a public  
hearing may be properly held on its substantive contents.

Committee on Health that is attached to this report, your  
Committee is in accord with the action to report out H.B. No.  
2172, as amended herein, and recommends that it be recommitted to  
the Committee on Health, for the purpose of holding a public  
hearing thereon, in the form attached hereto as H.B. No. 2172,  
H.D. 1.
