"A BILL FOR AN ACT MAKING AN APPROPRIATION FOR KALANIHUIA ELDERLY HOUSING PROJECT,"

The purpose of this bill is to improve security at the Kalanihūia Elderly Housing Project by appropriating \$21,091 for fiscal year 2008-2009 to hire on contract at least one full-time security officer for the Project.
