Your Committee on International Affairs, to which was referred H.C.R. No. 103 entitled:

"HOUSE CONCURRENT RESOLUTION APPROVING AND AUTHORIZING THE ESTABLISHMENT OF A STATE-PROVINCE AFFILIATION BETWEEN THE STATE OF HAWAII OF THE UNITED STATES OF AMERICA AND THE PROVINCE OF NEGROS ORIENTAL OF THE REPUBLIC OF THE PHILIPPINES,"
