Your Committee on Health, to which was referred H.C.R. No. 373 entitled:

"HOUSE CONCURRENT RESOLUTION EXPRESSING GRATITUDE TO THE RESIDENTS OF KALAUPAPA AND THEIR FAMILIES FOR THE SACRIFICES THEY MADE LIVING IN ISOLATION ON THE ISLAND OF MOLOKAI AND FOR BEING SEPARATED FROM SOCIETY,"

The Department of Health supports this concurrent resolution.

As affirmed by the record of votes of the members of your Committee on Health that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 373 and recommends its adoption.
