The purpose of this resolution is to dedicate the University of Hawaii (UH) School of Social Work in honor of Myron "Pinky" Thompson by changing the name of the school to the "Myron Thompson School of Social Work."

The two senators of Hawaii's congressional delegation,
Association of Hawaiian Civic Clubs, Kamehameha Schools, National
Association of Social Workers, Hawaii Chapter, Papa Ola Lokahi,
Partners in Development Foundation, and several concerned
individuals testified in support of this resolution. The UH at
Manoa School of Social Work offered comments.

Your Committee has amended this resolution by:

(1) Requesting the UH Board of Regents to consider making an exception to its rule that a UH building or school can be named only if a minimum \$25,000,000 donation is made, in light of Myron "Pinky" Thompson's momentous

contributions to the field of social work for the benefit of the entire state and its people; and

(2) Making technical, nonsubstantive amendments for clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Higher Education that is attached to this report, your Committee concurs with the intent and purpose of H.R. No. 234, as amended herein, and recommends its adoption in the form attached hereto as H.R. No. 234, H.D. 1.
