begs leave to report as follows:

The purpose of this resolution is to request the Hawaii State
Center for Nursing to encourage parties to work together for the
common goal of increasing the supply of well-educated and
dedicated nurses.

Testimony in support of this measure was received from the
University of Hawaii System, Hawaii State Center for Nursing,
Hawaii Statewide Nursing Consortium, Leahi Hospital, Hawaii
Government Employees Association, AFSCME Local 152, AFL-CIO, AONE
Hawaii Chapter, and numerous concerned individuals.

The State Board of Nursing (Board) supported this measure
with an amendment to delete reference to the nursing program at
Leeward Community College as it has not been approved by the Board
and has not attained national accreditation by the National League
for Nursing or the Commission on collegiate Nursing Education.


As such, your Committee has amended this measure to reflect
