was referred S.B. No. 2083, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO THE SUPERVISION OF ADULT
OFFENDERS,"

begs leave to report as follows:

The purpose of this measure is to improve the operation and
effectiveness of the State Council for Interstate Adult Offender
Supervision by:


- (1) Increasing the membership of the State Council for
Interstate Adult Offender Supervision;
- (2) Authorizing the Judiciary to assess a fee on
applications made by a parolee or probationer for a
transfer to Hawaii; and
- (3) Establishing one full-time coordinator position under
the Judiciary, to help carry out the duties of the
Interstate Compact for the Supervision of Adult
Offenders.

The Judiciary and Hawaii Paroling Authority supported this
bill. The Community Alliance on Prisons submitted comments.



As affirmed by the record of votes of the members of your Committee on Public Safety & Military Affairs that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 2083, S.D. 2, and recommends that it pass Second Reading and be referred to the Committee on Finance.
