Your Committee on Judiciary, to which was referred S.B. No. 966 entitled:

"A BILL FOR AN ACT PROPOSING AN AMENDMENT TO ARTICLE V, SECTION 1, OF THE HAWAII CONSTITUTION, TO CHANGE THE AGE QUALIFICATION FOR THE OFFICES OF GOVERNOR AND LIEUTENANT GOVERNOR FROM THE AGE OF THIRTY YEARS TO THE AGE OF TWENTY-FIVE YEARS,"

The purpose of this bill is to propose an amendment to the State Constitution to reduce the age qualification for the offices of the Governor and Lieutenant Governor from 30 to 25 years-of-age.


Many concerned individuals testified in support of this bill.
