Your Committee on Tourism & Culture, to which was referred
S.C.R. No. 225, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION ACKNOWLEDGING THE WORK OF THE
STATE FOUNDATION ON CULTURE AND THE ARTS IN SUPPORTING ARTS
AND CULTURE IN HAWAII, AND REQUESTING THAT AS AGENCIES MOVE
FROM THE NO. 1 CAPITOL DISTRICT BUILDING, THE VACATED SPACE
SHALL BE ASSIGNED TO THE STATE FOUNDATION ON CULTURE AND THE
ARTS AND THE STATE ART MUSEUM, "

begs leave to report as follows:

The purpose of this concurrent resolution is to officially
acknowledge and recognize the work of the State Foundation on
Culture and the Arts (SFCA) in supporting arts and culture in
Hawaii. In addition, this measure:

- (1) Requests that, as agencies move from the No. 1 Capitol
District Building, the vacated space be assigned to the
SFCA and the State Art Museum (Museum) for the future
growth and development of these entities; and
- (2) Requests that at such time when the SFCA and the Museum
occupy the majority of square footage in the building,
the building be renamed "The Hawaii State Art Museum."



SFCA supported this measure.

As affirmed by the record of votes of the members of your Committee on Tourism & Culture that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 225, S.D. 1, and recommends its adoption.
