Your Committee on Ways and Means, to which was referred H.B. No. 3197, S.D. 1, entitled:

The purpose of this measure is to appropriate \$21,253,032 from the state highway fund for operating and maintenance costs of the state highway system for fiscal year 2007-2008.


Your Committee received testimony in support of this measure from the Hawaii Transportation Association.


