The purpose of this measure is to appropriate moneys for the
Hawaii state commission on the status of women for programming,
travel, and office expenses.

Your Committee received testimony in support of this bill
from the Commission on the Status of Women, Kokua Council, the Sex
Abuse Treatment Center, and a private individual.


The Commission on the Status of Women explained that these
funds were not included in the Executive budget but would provide
funds to continue successful programs such as Women's Health Month
which began in 1994, the Oral History Project, Women's History
Month, Ready 2 Run to help women understand the political process.
All of these programs are directed at helping women achieve
economic self-sufficiency, the Commission's number one priority.

As affirmed by the record of votes of the members of your
Committee on Judiciary and Labor that is attached to this report,
your Committee is in accord with the intent and purpose of S.B.
