Madam:

Your Committee on Health, to which was referred S.B. No. 1458  
entitled:

"A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE  
DEPARTMENT OF HEALTH FOR THE EMERGENCY MEDICAL SERVICES AND  
INJURY PREVENTION SYSTEM BRANCH,"

begs leave to report as follows:

The purpose of this measure is to make an emergency  
appropriation to the Department of Health for the Emergency  
Medical Services and Injury Prevention System Branch.


Your Committee received testimony in support of this measure  
from the Department of Health, State Department of Defense, and  
Healthcare Association of Hawaii.

Your Committee finds that the requested appropriation is  
required to pay for \$1,900,000 emergency aeromedical services on  
Oahu for fiscal year 2006-2007. The additional funds are  
necessary to cover the reimbursement costs associated with the  
delivery of service by the Hawaii Army National Guard in providing  
emergency aeromedical services that were previously provided by  
the United States Army.

As affirmed by the record of votes of the members of your  
Committee on Health that is attached to this report, your  
Committee is in accord with the intent and purpose of S.B.  
No. 1458 and recommends that it pass Second Reading and be  
referred to the Committee on Ways and Means.




