Your Committees on Economic Development and Taxation and
Tourism and Government Operations, to which was referred S.B.
No. 2569 entitled:

"A BILL FOR AN ACT RELATING TO THE MUSEUM OF HAWAIIAN MUSIC
AND DANCE,"

beg leave to report as follows:

The purpose of this measure is to extend the interim and
final reporting deadlines for the Museum of Hawaiian Music and
Dance Committee, established by Act 230, Session Laws of Hawaii
2007.

Testimony in support of this measure was received from the
Office of Hawaiian Affairs, the Hawai'i Tourism Authority, and
three members of the Museum of Hawaiian Music and Dance Committee.
The State Foundation on Culture and the Arts submitted comments.

Your Committees find that due to delays in funding, the
Museum of Hawaiian Music and Dance Committee was unable to hold
its first meeting until December 2007. The fourteen-member group
is now meeting on an accelerated schedule, has secured the
services of a consultant, and expects to comply fully with the
revised reporting dates of September 15, 2008, for an interim
report, and no later than twenty days prior to the Regular Session
of 2009 for the final report.

As affirmed by the records of votes of the members of your
Committees on Economic Development and Taxation and Tourism and
Government Operations that are attached to this report, your


