Your Committee on Health, to which was referred S.B. No. 2742
entitled:

"A BILL FOR AN ACT AUTHORIZING THE ISSUANCE OF GENERAL
OBLIGATION BONDS AND MAKING AN APPROPRIATION FOR THE MAUI
REGION OF THE HAWAII HEALTH SYSTEMS CORPORATION,"

begs leave to report as follows:

The purpose of this measure is to ensure the continued
provision of quality health care services at Maui Memorial Medical
Center by authorizing the issuance of general obligation bonds in
the amount of \$10,000,000 for the modernization of Maui Memorial
Medical Center, including a new obstetrics and gynecology wing,
additional operating rooms, and the relocation of psychiatric
units.

Your Committee received testimony in support of this measure
from Maui Memorial Medical Center.

Your Committee finds that the Maui Health Initiative Task
Force reported to the Legislature the need for modernization of
health care facilities at Maui Memorial Medical Center. This
modernization will ensure the Maui community has continued access
to up-to-date technology systems and facilities and culturally
sensitive health care services.


As affirmed by the record of votes of the members of your
