Requires motor vehicle insurers to reduce the rates of any individual who successfully completes a driver improvement course. (HB2093

HB 2372, HD1 (HSCR99-08) Status

RELATING TO TIME SHARE PLANS.

TAC, CPC

Exempts from the time share law the offer or sale of an additional interest in a time share plan to an existing purchaser in the same time share plan; provided that certain conditions are met. Exempts from the time share law the offer or sale by a developer, in Hawaii, of a time share interest in a time share plan located outside of Hawaii to an individual who currently owns a time share interest that was purchased from the developer, or the developer's affiliates; provided that certain requirements are met.

RELATING TO TATTOOING.

WLH, CPC

Exempts experts in the practice of Kakau, traditional Hawaiian tattooing, from current tattoo licensure laws. (HB2887 HD1)

Allows a master's degree candidate in a nursing program who has completed the pre-licensure component of the program to apply for a

license by examination to practice as a registered nurse.

HB 2449, HD1 (HSCR354-08) Status		PROTECTING CHILDREN FROM CERTAIN TOXIC PRODUCTS. Prohibits the manufacture, sale, and distribution of products for young children that contain bisphenol-A or phthalates. Requires manufacturers to choose safe alternatives. (HB2449 HD1)	HLT, CPC
