SB 2980 RELATING TO THE HOUSING LOAN AND MORTGAGE CPH, WAM PROGRAM. **Testimony** Provides an increase in Hula Mae multifamily revenue bond authority from \$400 million to \$500 million to provide financing assistance for the development and preservation/rehabilitation of affordable housing.
