RELATING TO TEACHERS.

EDN/LAB, FIN

Provides teachers receiving satisfactory service performance evaluations with annual step increases for five years. Denies public school teachers with marginal service performance evaluations from receiving annual step increases. Excludes teachers at the top salary levels from receiving annual step increases.

DECISION MAKING TO FOLLOW

- The date and time of the hearing;
- Measure number; and
