RELATING TO TAXATION.

EDT/ENE, WAM

Amends the license tax rules to except entities that use diesel oil for power-generating facilities from the additional 1 cent increase in diesel oil license taxes.

Decision Making to follow, if time permits.

Persons wishing to testify should submit testimony in one of the following ways at least 24 hours prior to the hearing. Any testimony received after 6:00 PM the day before the hearing will not be distributed to the Committee or available to the public until after the hearing ends. As a result, the Committee will not be able to consider written testimony received after 6:00 PM in its decisions.
