When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.
- By Email: Testimony may be emailed if less than 5 pages in length, to the Legislature's Public Access Room at testimony@capitol.hawaii.gov. Please indicate to which committee the testimony is being submitted and the date and time of the hearing. Email sent to individual offices or any other Senate office will not be accepted.
- **Anyone submitting testimony on the day of the hearing must make 20 copies (two-hole punched on top and, if more than one page, stapled) of their testimony and deliver to the hearing room before the hearing starts.**
