Authorizes DOTax to study and evaluate the economic impact of  
existing and proposed State tax incentives. Authorizes DOTax to

of businesses that have claimed the High Technology Business  
Investment Tax Credit. Requires DOTax to report annually to the  
Legislature, until 2012, on its findings of the economic impact of the  
two tax credits. Appropriates funds.

benefits are provided to the employee due to the employee's status as a  
reciprocal beneficiary or a domestic partner.

Expands the renewable energy technologies tax credit to include solar electric energy systems.


