<u>HB 2735, HD2</u> <u>(HSCR878-08)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PUBLIC HOUSING. Appropriates funds for the contract hiring of at least three full-time security guards, police officers, or public safety officers with police powers at Mayor Wright Homes public housing complex. Requires a report to the Legislature on the progress of security improvements at Mayor Wright Homes. Effective 7/1/2020. (HB2735 HD2)	HSP, WAM
<u>HB 3059, HD1</u> <u>(HSCR882-08)</u> <u>Testimony</u> <u>Status</u>	RELATING TO LOW-INCOME HOUSING TAX CREDITS. Reduces the period over which state low-income housing tax credits are taken from ten years to five years. (HB3059 HD1)	HSP, EDT, WAM
