RELATING TO WORKPLACE TRAINING

PSM, FIN

Requires the department of public safety to develop a curriculum on ethnic and cultural diversity in the workplace and its implications

on working with offenders and their families.

HB 2530

RELATING TO CONTROLLED SUBSTANCES

HLT, PSM, JUD

Requires the narcotics enforcement division of the department of public safety to maintain an electronic purchase logbook for sales

of pseudoephedrine and related substances. (HB2530 HD1)

HB 2849

RELATING TO ALLOWANCE ON SERVICE RETIREMENT

PSM/LAB, FIN

Makes police radio dispatchers class A members of the employees' Retirement system. Exempts Act from prohibition against benefit Enhancements, including reduction in retirement age when there is An unfunded liability established in section 88 122(e), HRS by Act 256,

HB 2567

RELATING TO DISASTER PREPAREDNESS

HLT, PSM, FIN

Funds a study to assess the structural integrity of each hospital and nursing home facility to determine their ability to withstand

hurricanes and earthquakes. (HB2567 HD1)

HB 2963

RELATING TO NATURAL DISASTERS

PSM, FIN

Appropriate funds for structural and non-structural earthquake recovery and mitigation projects, provided that the projects include

measures to ensure survivability in future disasters with a



HB 2857

RELATING TO TAX CREDITS

PSM, FIN

Provides a one-time nonrefundable tax credit to assist the victims of the December 2007 flood and wind storm in upcountry Maui and

other areas of the 12th representative district.

HB 2988

RELATING TO TAX CREDITS

PSM, FIN

Provides a \$1,000 tax credit to Hawaii national guard members who have served in a combat zone or qualified hazardous duty area.

HB 2663

RELATING TO EMERGENCIES

PSM, FIN

Clarifies when the governor may exercise emergency powers

HB 2664

RELATING TO DISASTER RELIEF

PSM, FIN

Clarifies the use of the governor's emergency powers. Clarifies that the governor shall not utilize the power to suspend laws authorized under the Civil Defense and Emergency Act when the State is attacked for purposes of noncivil defense situations unless there is a tangible and measureable threat to the people or environment of the State. Establishes that certain provisions of the State's disaster relief chapter are operative and supersede provisions of the Civil Defense and Emergency Act in times when an emergency arises that is not considered a civil defense emergency. States that any emergency powers in force prior to the effective date of this measure expire at the end of the 2008 regular session unless reauthorized

by the legislature.

an account in the state treasury to be known as the veterans' gift trust fund

HB 3019

RELATING TO VETERANS

PSM, FIN

Establishes a veterans bonus for qualifying veterans
