<u>HB 1977</u>	RELATING TO TRAFFIC VIOLATIONS. Establishes a \$150 fine for running a red light.	TRN, JUD
<u>HB 1980</u>	RELATING TO TRAFFIC INFRACTIONS. Requires district court to delete from a driver's traffic abstract any violation which the driver is found not to have committed.	TRN, JUD
<u>HB 2058</u>	RELATING TO FINES FOR DRIVING UNDER THE INFLUENCE OF AN INTOXICANT. Increases fines for driving after license suspended or denied for noncompliance with an order of support. Increases the fine for first time DUI offenders. Requires the state director of finance to pay fines received from DUI offenders to the county in which the offense occurred for use in road design, construction, maintenance, and repair.	TRN, JUD, FIN
<u>HB 2093</u>	RELATING TO MOTOR VEHICLE INSURANCE. Requires motor vehicle insurers to reduce the rates of senior citizens who successfully complete a driver improvement course.	TRN, CPC
<u>HB 2075</u>	RELATING TO MOTOR VEHICLE INSURANCE RATE FILINGS. Requires insurers to file rates that provide for an appropriate reduction in premium charges for insureds who are 65 years of age and older after successfully completing a motor vehicle accident prevention course. Requires the department of transportation to develop the motor vehicle accident prevention course.	TRN, CPC
<u>HB 2056</u>	RELATING TO PEDESTRIAN SAFETY. Appropriates funds for pedestrian safety improvements by the State and counties.	TRN, FIN

HB 2034

RELATING TO UNATTENDED CHILDREN IN MOTOR VEHICLES.

TRN, JUD

Makes it a violation of the statewide traffic code to leave a child unattended in a motor vehicle. Effective on approval. Requires the examiner of drivers to test driver's license applicants for knowledge of this offense. Requires notice of law in rental cars. Effective on 10/1/2008.

HB 1987

RELATING TO MOTOR VEHICLES.

TRN, JUD

Prohibits young drivers from using a telephone while operating a motor vehicle.

DECISION MAKING TO FOLLOW


