RELATING TO AIR POLLUTION CONTROL.

TRN, TAC

Creates a three-year pilot program to be established and implemented by the department of health, with results to be reported to the legislature. Establishes that the findings of the program will determine the current level of and health and environmental impact of air pollution caused by bunker fuel-burning cruise vessels docked or moored in Nawiliwili harbor, and the effect of requiring cruise ships to switch to .5 per cent or lower sulfur fuels while docked or moored.
