<u>HB 3301</u>	RELATING TO FISHING. Designates the Honaunau and Hookena Community-based Subsistence Fishing Areas in the South Kona District of the island of Hawaii. Requires the Department of Land and Natural Resources to consult with the inhabitants of the respective fishing areas.	WLH, FIN
<u>HB 3175</u>	RELATING TO COMMERCIAL MARINE FISHING REPORTS. Amend the title of section 189-3, Hawaii Revised Statutes, from "monthly catch" to "commercial marine fishing reports" to more accurately reflect that reports will be filed on a "per catch" basis.	WLH, FIN


Testimony submitted will be placed on the Legislative Web site after the hearing adjourns. This public posting of testimony on the Web site should be considered when including personal information in your testimony.
