<u>SB 2758</u> <u>Testimony</u>	RELATING TO AN AUDIT OF THE HAWAII DISABILITY RIGHTS CENTER. Requires the auditor to perform a financial and management audit of the Hawaii Disability Rights Center.	HSP, WAM
<u>SB 2930</u> <u>Testimony</u>	RELATING TO ADULT RESIDENTIAL CARE HOMES. Clarifies licensure requirements for adult residential care homes.	HSP
<u>SB 2857</u> <u>Testimony</u>	RELATING TO HOME CARE AGENCIES. Requires home care agencies to be licensed by the Department of Health. Appropriates funds.	HSP, WAM
<u>SB 3164</u> <u>Testimony</u>	RELATING TO LONG-TERM CARE. Allows persons eligible to receive Medicaid funds for care at nursing home facilities to remain at home and receive home and community-based long-term care.	HSP, WAM
<u>SB 3172</u> <u>Testimony</u>	RELATING TO RENTAL ASSISTANCE. Provides qualified rental assistance applicants up to six months to find a qualified rental dwelling.	HSP, WAM
<u>SB 3173</u> <u>Testimony</u>	RELATING TO KUKUI GARDENS. Appropriates \$26,000,000 in general obligation bonds to finalize the sale of the Kukui Gardens housing project.	HSP, WAM
<u>SB 3255</u> <u>Testimony</u>	RELATING TO LONG TERM CARE. Establishes a long term care commission to research what resources are necessary to meet state long term care public policy goals and to recommend a program and funding mechanism that can provide these services. Appropriates funds. Sunsets on 12/01/10.	HSP, WAM
<u>SB 2208</u> <u>Testimony</u>	RELATING TO DOMESTIC VIOLENCE. Provides protections for domestic violence victims in rental housing.	HSP, JDL



<u>SB 2216</u>	RELATING TO PROSTITUTION.	HSP, WAM
<u>Testimony</u>	Requires the department of human services to contract the services of a health and human services provider to establish a pilot prostitution prevention education and diversion program.	
<u>SB 2245</u>	RELATING TO UNATTENDED CHILDREN IN MOTOR VEHICLES.	HSP, JDL
<u>Testimony</u>	Makes it a violation of the statewide traffic code to leave a child unattended in a motor vehicle. Effective on approval. Requires the examiner of drivers to test driver's license applicants for knowledge of this offense. Requires notice of law in rental cars. Effective on 10/1/2008.	
<u>SB 2317</u>	RELATING TO YOUTH PROGRAMS.	HSP, WAM
<u>Testimony</u>	Makes appropriation for the Palolo at-risk youth outreach program.	
<u>SB 2103</u>	RELATING TO CAREGIVER RECOGNITION DAY.	HSP
<u>Testimony</u>	Establishes an annual Caregiver Recognition Day on the first Saturday of November.	
<u>SB 2793</u>	RELATING TO ADULT RESIDENTIAL CARE HOMES.	HSP
<u>Testimony</u>	Clarifies licensure requirements for adult residential care homes.
