SB 2267 RELATING TO THE OFFICE OF INTERNATIONAL RELATIONS. TIA, WAM
Testimony Establishes a peace mission committee within the office of international affairs to plan and implement peace missions to other nations and organizations. Appropriates funds.

SB 2800 RELATING TO HARBORS. Pending Referral
Testimony Extends the department of transportation's jurisdiction and administrative authority over Honolulu harbor Pier 2 to include lots 1, 2, 4, and 5 of the Forrest Avenue subdivision, as well.

SB 2365 RELATING TO TRANSPORTATION. TIA/ENE
Testimony Provides that high occupancy vehicle lanes may be used by hybrid vehicles.

ENE/TIA

SB 2549 RELATING TO ELECTRIC AUTOMOBILES. ENE/TIA
Testimony Requires the department of business, economic development, and tourism to develop an implementation plan to increase electric automobile use in Hawaii.


