I. Background and Summary

1. A brief description of the applicant's background.

In the 2007 Legislative Session, bills were introduced to establish September 21 annually as Peace Day in Hawai`i to promote peace programs, improve international relations, and increase educational awareness of peace. These measures were initiated by the Hawai`i Federation of Young Buddhist Association, which is under the Honpa Hongwanji Mission of Hawai`i and quickly gained support from the Spark M. Matsunaga Institute for Peace at the University of Hawai`i at Manoa, Lion's Club, Domestic Violence Clearing House, Shinnyo-en Foundation, Na Lei Aloha Foundation, Jodo Mission of Hawai`i, Hawai`i Christian Science, Retail Merchants of Hawai`i, Hawai`i an Telcom, Alexander & Baldwin Foundation, Archinoetics LLC, Dean Foods Company, Hawai`i Carpenters, Referentia Systems Incorporate, Oceanit, and other organizations. House Bill 345 became law as Act 23 on April 18, 2007 and as a result, Hawai`i became the first state in the United States to recognize a Peace Day.

After the passage of Act 23, Speaker Calvin K.Y. Say appointed Representative Jon Riki Karamatsu and Senate President Colleen Hanabusa appointed Senator Carol Fukunaga to co-chair the newly created Peace Day Hawai`i Committee to plan the events for Peace Day Hawai`i 2007. The committee included members from the Hawai`i State Legislature, the administration of Governor Linda Lingle, University of Hawai`i College of Education, Spark Matsunaga Institute for Peace, College of Tropical Agriculture and Human Resources, Oceanit, Lions Club, Honpa Hongwanji Mission of Hawai`i, Jodo Mission of Hawai`i, and United Nations Association of Hawai`i. The Peace Day Hawai`i Committee acquired its 501c3 nonprofit status through the University of Hawai`i Foundation.

In August 2007, the Peace Day Hawai'i Committee initiated an "Expressions of Peace" Visual and Literary Art Contest for all ages. A majority of the art was displayed in the halls of the Hawai'i State Capitol auditorium from September 2007 to October 2007. The committee chose winners for various age groups that were to be announced at the Peace Day ceremony.

On September 21, 2007, the committee held the first annual Peace Day Hawai'i inaugural celebration (see Appendix B: Brochure copy of the program) at the Hawai'i State Capitol. From 3:00 P.M. to 5:00 P.M., we held a Peace Forum led by the Matsunaga Institute for Peace in the Hawai'i State Capitol auditorium. Also, from 3:00 P.M. to 5:00 P.M., we held a reception for leaders of organizations that donated funds to the Peace Day Hawai'i Committee and leaders of various non-profit and religious organizations.

The Peace Day ceremony was held between 5:30 P.M. to 7:30 P.M. on September 21, 2007 in the rotunda of the Hawai'i State Capitol. Included in the program were the following: Youth co-emcees, Hawai'i an chant, hula, speeches from elected officials, release of rainbow pigeons, opera singer from Honolulu Symphony, Hongwanji Mission School choir, Pacific Buddhist Academy choir, Peace Day Award for "Distinguished Peacemaker", cellist and violinist from the Honolulu Symphony, Model United Nation student speakers, professional singer and ukulele player Rai'atea Helm, presentation of awards for the "Expressions of Peace" Visual and Literary Art Contest, and silent candlelight prayer with various religions.

In January 2008, we decided to expand our peace projects and services such as creating a peace education curriculum for K-12 students, donating care package for survivors of violence in Hawai'i and orphans of war abroad, implementing peace forums, and revitalizing the Diamond Head Millennium Peace Park. We are currently in the process of incorporating a new non-profit organization and shifting our organization out of our current non-profit organization, the University of Hawai'i Foundation.

2. The goals and objectives related to this request.

Major Goals

A. Peace Day events.

Goal: Our goal is to stabilize the continuing management and organization of Peace Day Hawai'i celebrations and alliance with the State in fulfillment of Act 23 signed by Governor Lingle on April 18, 2007 making Peace Day a recurring annual event: "to promote peace programs, improve international relations, and increase educational awareness of peace." We want to bring people together from various organizations, cultures, and religions under a common goal of reducing violence and promoting peace. These events are open to the public.

Objective #1: To have successful Peace Day Hawai'i events on September 21, 2008, which includes: peace forums, speeches, recognition awards, entertainment, student education

projects, peace educational information, public community programs, invited local and international speakers, and silent candlelight prayer.

Objective: #2: To expand the local and international network of relationships with Hawai'i community groups, individuals, and organizations who want to continue their annual participation in Peace Day events.

Objective: #3: To increase opportunities for fundraising and stabilize our network of donors in the short-run and long-term.

B. Promote peace education programs.

Goals: Our organization has members who are educators at the University of Hawai'i at Manoa, College of Education and East -West Center who are interested in creating a comprehensive peace education curriculum for Hawai'i 's K-12 grade school students beyond the current postgraduate focus at the University. One such educational program we are planning to implement is the nationally recognized United Nations Global Classrooms.

Objective #1: Purchase United Nations Global Classrooms educational materials for Hawai'i K-12 public and private schools.

Objective #2: Align the Global Classrooms curriculum (which is already aligned with national standards) with Hawai'i State Standards.

Objective #3: Provide follow-up teacher training and in-service workshops for integrating the United Nations Global Classrooms curriculum into teachers' lesson plans.

Objective #4: Tailoring the curriculum to accommodate local Hawai'i conditions and current initiatives that address sustainability, environmental ecology and social justice issues.

Objective #5: Continue the advocacy, development, and collaboration of student peace clubs among and between both public and private schools throughout Hawai'i.

C. Peace forums and conferences.

Goals: Our goal is to build coalitions for sustaining cultures of peace and reduce existing conflicts between people, organizations, and nations. Citizens of Hawai'i can have the opportunity to express their views and engage in activities together towards creating a culture of peace in Hawai'i and abroad.

Objective #1: Plan local, national and international peace education forums and conferences to bring diverse people together from various governments, organizations, cultures, and religions.

Objective #2: Provide an international student film festival that would bring awareness to students of existing global problems addressed by the United Nations and bring other students and peace advocates to Hawai'i to discuss these issues.

Objective #3: Provide ways and opportunities where Hawai'i students and citizens can become actively engaged with students and citizens of other countries to increase global understanding and communication.

D. Support survivors of violence.

Goal: Provide aide and assistance to survivors of violence in Hawai'i and orphans of war both at home and abroad.

Objective #1: We are planning to create a care package for survivors of violence in Hawai'i. Specifically, we are planning to make custom designed shirts for survivors of sexual violence who are taken to the Sex Abuse Treatment Center. Survivors have to give up the clothing they are wearing for evidence in sexual assault cases. The shirts are for them to wear to give comfort and maintain dignity. In addition, we want to create a custom stuff animal to help comfort them in this difficult time, especially for children. We are also looking into giving survivors educational materials such as an inspirational book. Similarly, we want to offer these items to survivors of abuse and domestic violence.

Objective #2: Our long term goal is to exchange goodwill with other regions of the world by helping orphans of war through a care package that would include medical vaccines, medical supplies, clothing, educational materials, food, and stuffed animals. Our goal is to lessen the cycle of violence by positively affecting the lives of orphans of war in hopes that fewer children will grow up and take revenge through violence. Our intent is to counter the hatred some individuals may hold towards our country through goodwill.

E. Improve the grounds of the Diamond Head Millennium Peace Garden.

Goal: We want to increase the knowledge of Hawai'i's peace mission and improve international relations by upgrading the grounds of the Diamond Head Millennium Peace Garden as a local gathering place and tourist visitor site. It will also be a location to recognize leaders and organizations that have promoted peace in Hawai'i.

Objective #1: Commission the design and creation of a statue that would be symbolic of the important mission of peace through Hawai'i's citizens' efforts. For example, honoring the late U.S. Congresswoman Patsy Mink with the construction of a statue similar to the late U.S. Senator Spark M. Matsunaga statue near completion in the Children's Garden at Hanapepe, Kauai; or a statue representing the international students of the Millennium Young People's Congress who originally were involved in the creation of the Peace Garden.

Objective #2: Commission a landscape architect to layout an overall design for the Peace Garden.

Objective #3: Stabilize the routine organization in maintaining the grounds of the gardens with students from public and private schools on O`ahu and neighboring islands in cooperation with Rotary Club, Youth for Environmental Services, Institute for Human Rights, the United Nations Association – Hawai'i branch, University of Hawai'i College of Education, and the University of Hawai'i at Manoa/East West Center United Nations Student Club.

Objective #4: Initiate long term objectives in creating the Peace Garden as an educational site where students, Hawai`i residents, and visiting tourists may learn about the history of the peace movement in Hawai`i and the variety of organizations, state leaders, projects, and citizens involved in creating a culture of peace in Hawai`i and abroad. Showcase the Diamond Head Millennium Peace Garden as a potential model to expand to other sites on neighboring islands and around the world.

3. State the public purpose and need to be served.

Purpose #1: **We need to get more people involved in community service in order to empower them in everyday simple acts of compassion to reduce violence and make our community and world more peaceful.** The public purpose is to encourage people to play an active democratic role in making our community and world more peaceful by becoming aware of organizations in which they may participate that aim to reduce violence or support survivors of violence. The more people learn and identify with others who value non-violence and the more empowered they will be in creating peace for their personal and the public Good.

Purpose #2: **We need to recognize individuals and organizations that played a major role in making our community and world more peaceful.** Showing appreciation for individuals and organizations will inspire others to do the same or even more. We need to translate 'volunteerism' into a spirit of giving that is embraced as a natural way of being that nurtures simultaneously self and society.

Purpose #3: **It is important to educate our people, especially our children and K-12 students and teachers, in a wholistic and comprehensive way about how peace can be achieved and nurtured in everyday living.** We need to 'walk the talk' by providing educational packages that integrate peace making strategies, revere peacemakers and events in local and global history, provide training to reduce conflicts and violence, bring awareness of the diversity of cultures and values in achieving peace at the personal level, in relation with others, in professional/business/school/community building throughout Hawai`i and abroad.

Purpose #4: **There is a need to find common strengths among various religions, organizations, governments, and individuals, so that we may strive to resolve our difference and avoid conflict and violence.** Recognition, acceptance, and honoring diversity is achieved through the encouragement and practice of nonviolent forms of communication and problem solving. We need to make these learning opportunities available and accessible to our community.

Purpose #5: **Our organization will collaborate with other organizations, educational institutions, and government to reduce violence in Hawai`i and improve the United States relationship with other organizations and nations.** Hawai`i has long been touted as a potential ideal model of "global living" for countries around the world to look to as a

'standard' because of its intergenerational concentration in diversity of its ethnic and cultural populations. We need to make this vision a 'reality'.

Purpose #6: Reduce 2007 violence statistics in Hawai'i by 50% by 2027.

Purpose #7: There is a great need to improve the United States' relationship with other organizations and nations through the state of Hawai'i. We wish to upgrade the image of the U.S. that has fallen in stature as a leading example of democracy among world nations.

Purpose #8: Prevent future unnecessary wars. We need to transform our minds and hearts from its entrenchment and ways of perpetuating cultures of war to emphasize existing patterns and discovery in new ways of thinking, habits of being, and manners of relating to all life on the planet Earth.

4. Describe the population to be served.

All citizens of Hawai'i.

This project will benefit all citizens - families, students, professional businesses, government leaders, etc. in the community by providing educational materials, workshops, events, and activities that promote an awareness of peace and ways to incorporate peace practices in their daily lives. It will also provide opportunities for exchanges between Hawai'i citizens and citizens of other countries to come together in pursuit of common understandings about each others' cultures, visions of peace, and cooperative sharing of knowledge and practices in achieving cultures of peace.

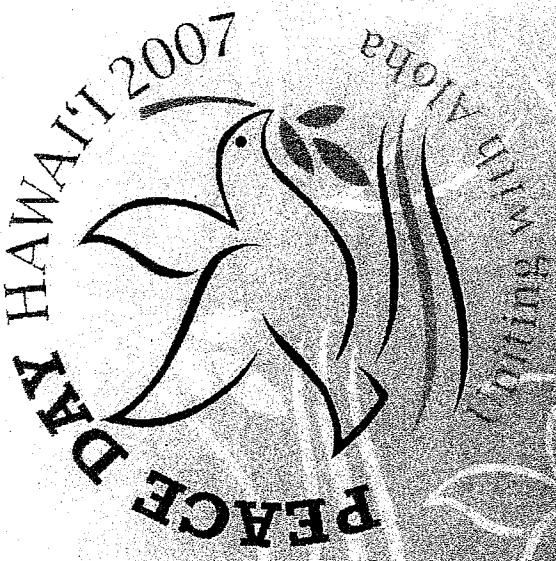
