"Mr. Speaker, I rise in strong support of HCR 117.

"The historic value of the Hanapepe Salt Ponds is priceless. Generations of families have been continuing the tradition of Hawaiian salt making for at least 50 years. Culturally, Hawaiian salt plays a big part in the life of native Hawaiians.

"Unfortunately, over the past fifty years, there have been negative impacts on the salt beds due to the development in the surrounding area. I believe that the Hanapepe Salt Ponds are the only viable salt ponds left in the State of Hawaii, and it is imperative that we protect this important cultural part of Hawaii.

"To address this problem, I would like all State, County and community agencies to meet and develop a Hanapepe Salt Pond resource management plan, which this HCR will do.

"Thank you, Mr. Speaker."

Representative Mizuno rose to speak in support of the measure, stating:

"Mr. Speaker I also stand in strong support for Stand. Com. Rep. 1505-08 and if I can have the words, not the written comments but the words that were stated by the previous speaker placed into the Journal as if they were my own. And I just wanted to say, it truly was a blessing for us to take a site visit and to see the Hanapepe salt ponds and understand that generation after generation have worked on that. It's a devotion that truly represents the awesome spirit of Aloha. Thank you, Mr. Speaker."

Representative Evans, for the Committee on Public Safety & Military Affairs presented a report (Stand. Com. Rep. No. 1520-08) recommending that H.R. No. 216, be adopted.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.R. No. 216, entitled: "HOUSE RESOLUTION URGING THE CITY AND COUNTY OF HONOLULU, THE

COUNTY OF HAWAII, AND KAUAI COUNTY TO PROVIDE AN INCREASE IN INFORMATION THAT WILL INFORM AND ENABLE HOMEOWNERS TO GAIN KNOWLEDGE OF THE FLOOD ZONE THAT HOMES ARE LOCATED IN AND THE RISKS OF FLOODING," was adopted, with Representatives McKelvey, Nakasone and Takai being excused.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and S.B. No. 2425, SD 1, entitled: "A BILL FOR AN ACT RELATING TO ARSON," passed Second Reading and was placed on the calendar for Third Reading with Representatives McKelvey, Nakasone and Takai being excused.

Representative Waters, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1523-08) recommending that S.B. No. 2363, SD 2, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and S.B. No. 2363, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SEXUAL ASSAULT," passed Second Reading, and was placed on the calendar for Third Reading with Representatives McKelvey, Nakasone and Takai being excused.

Representative Waters, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1524-08) recommending that S.B. No. 3203, SD 1, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Caldwell moved that the report of the Committee be adopted, and that S.B. No. 3203, SD 1, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative B. Oshiro.

Representative Evans rose to speak in opposition to the measure, stating:

"Thank you. On Standing Committee Report 1524, Senate Bill 3203, SD 1, HD 1, I stand in opposition. Thank you. I think there's some good intention here, but I'm very concerned about really the outcome if we pass this bill. This came about because in Kaka'ako there's a homeless woman, that I don't know how she did it, but she got animal cages and she stacks them up and I think she has 20 or 30. The community is not very happy seeing that, and I think she lives in an alley with these pets.

"People are really concerned that the City and County of Honolulu hasn't taken any action. If we have to pass a State law to deal with this so be it, but I voted no in Committee because I felt that we're dealing with a homerule issue. The City and County needs to go out

and deal with someone who possibly doesn't understand what she's doing.

"But I also want to point out, the more I think about this bill I remember in West Hawaii, I had people approaching me in tears saying the Humane Society was not taking care of the animals humanely. So I think the Humane Society should be careful because they may be under a misdemeanor themselves for this. The way the bill is written it says 'a person knowingly possesses more than 20 dogs, cats or a combination of dogs and cats and doesn't provide the necessary sustenance for each dog or cat.'

"When I question the person who really wanted this bill and I got into a lengthy discussion with him, he said if you approach this homeless woman she truly felt she was providing sustenance and love to these animals that were probably feral or abandoned animals. She felt she was doing the right thing. So I just have concerns about this law. Thank you."

Representative Brower rose to speak in support of the measure, stating:

"Thank you Mr. Speaker. In support. Just a few short comments. I want to thank the Chairs for hearing this measure. I just passed by this woman a few days ago. She is on State land and has about 30 to 40, if not more, small cages with shopping carts. And these animals are kept on the sidewalk in that area. I just want to encourage Members to support the measure and it may be a 'cruel to be kind' situation. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 3203, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ANIMAL HOARDING," passed Second Reading, and was placed on the calendar for Third Reading with Representative Evans voting no, and with Representatives McKelvey, Nakasone and Takai being excused.

Representative Herkes, for the Committee on Consumer Protection & Commerce presented a report (Stand. Com. Rep. No. 1525-08) recommending that S.B. No. 1805, SD 1, pass Third Reading.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and S.B. No. 1805, SD 1, entitled: "A BILL FOR AN ACT RELATING TO GENETIC COUNSELORS," passed Third Reading by a vote of 48 ayes, with Representatives McKelvey, Nakasone and Takai being excused.

Representative Herkes, for the Committee on Consumer Protection & Commerce presented a report (Stand. Com. Rep. No. 1526-08) recommending that S.B. No. 2159, HD 1, pass Third Reading.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and S.B. No. 2159, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PROFESSIONS," passed Third Reading by a vote of 48 ayes, with Representatives McKelvey, Nakasone and Takai being excused.

S.B. No. 2402, SD 1:

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, S.B. No. 2402, SD 1, entitled: "A BILL FOR AN ACT MAKING VARIOUS HOUSEKEEPING AMENDMENTS TO VOLUME 11 OF THE HAWAII REVISED STATUTES FOR THE PURPOSE OF CORRECTING ERRORS AND REFERENCES, AND CLARIFYING LANGUAGE," passed Third Reading by a vote of 48 ayes, with Representatives McKelvey, Nakasone and Takai being excused.

S.B. No. 2434, HD 1:

Representative Caldwell moved that S.B. No. 2434, HD 1, pass Third Reading, seconded by Representative B. Oshiro.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker I rise in opposition to SB 2434. Thank you, Mr. Speaker. I rise following the inspiration of that floor presentation and the Chair of Finance who really got us charged up and the *haka* that really put us in place as the previous quarterback and co-captain, it was the gist of what a contact sport is made of which is why I want to stand vehemently opposed to this bill.

"This is a bill that's premised on, I've called it IFL-phobia. On the Eiffel Tower you look down and you get fearful, when we look up to the Fifth floor we get fearful, it's the irrational fear of Lingle. This is another way of curtailing the Governor's power, Mr. Speaker. If we attack the problems of homelessness, affordable housing and other things as vigorously as we have attacked the Governor, I think we would be much better off.

"But Mr. Speaker the wisdom or the test of the pudding is in the tasting, as one of my learned colleagues from the Finance Committee said last week, the real test of what we're doing today will be if and when another Democrat becomes Governor, and how long that these bills will last. That will be the test of what we're doing today, Mr. Speaker."

Representative Marumoto rose to speak in opposition to the measure, stating:

"Mr. Speaker, I'm in opposition to this particular measure. In Senate Bill 2434, this seeks to change the Stadium Authority from nine members to 11 Members. I consider it a court packing bill. The Governor now picks seven of the nine members and two of them serve *ex officio*, the Superintendent of schools and the UH President, that brings it up to nine.

"Under this bill the Governor will only be able to pick three outright and then further select three more, but from a list from the Senate and another three more from a list from the House. Therefore the Governor goes from selecting seven of his or her choice, down to three members.

"In my estimation this bill sets forth an appointment cycle that would set in motion the first two-thirds, or the first six of the

authority vacancies will be determined by a list provided by the Senate and the House before the Governor could directly appoint the Governor's 7th, 8th or 9th members. That would be a long time away and I'm very sure we'll have a different governor by that time.

"But really it reduces appointment power of the Governor and DAGS has said this is an unnecessary bill. Although the purpose clause talks about importance in the large amount of money churning through the Stadium, there is no change required in the selection of this bill. No change in criteria or qualification for Authority members.

"I think this is a not so transparent attempt to chip away at the various powers allowed our Governor. Sometimes I question the motives of the introducer of these bills and I will remind you that the Senate will have two bites of this particular apple. They will be providing names to the Governor and also have advise and consent powers. So I think this is a bill where the Legislature starts intruding into Executive functions and the running of an Executive office and I think we should stick to our legislative powers and business. Thank you."

The motion was put to vote by the Chair and carried, and S.B. No. 2434, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STADIUM AUTHORITY," passed Third Reading by a vote of 41 ayes to 7 noes, with Representatives Ching, Finnegan, Marumoto, Meyer, Pine, Thielen and Ward voting no, and with Representatives McKelvey, Nakasone and Takai being excused.
