My Husband has a deep love for Waialua Moku and his Ohana legacy which spans 10 generations. His Grandfather taught him much and I was privledge to have known him. My family also has roots in Waialua, Waimea, Kawela and Kahuku.

My Grandfather used to own the current Surf and Sea in Haleiwa where he operated a merchant store. My Mother and her Second Husband resided at the entrance to Waimea Valley. Additionally, my Grandfather also owned and rented serveral houses adjacent to Catholic Chuch (St Paul) church just passed Waimea Bay. My Uncle was employed by Kahuku Sugar Company as an Office Manager while my Aunt was a school teacher at Kahuku School.

My Husband not only is attentive to ancestral burials but is also active in community affairs and attends the Northshore Neighborhood Board regularly. It is at these meetings that you find out about proposals and projects that may impact *Hawaiian* cultural and historical concerns which includes *Iwi Kupuna*.

This nominee hasn't done these types of involvement within the Waialua District and examples are lack of participation in Waimea Valley, Kuilima (Turtle Bay), Puaena Eco-Camp, Kaena NARS Fencing Project others whereas my Husband has and established working relationships with entities such as the Army, DLNR and private landowners within Waialua which includes Dole Foods.

My Husband and I participated in the *Puuiki Cemetery* awareness and cleanup where cemetery vandalism took place and we stopped it. He regularly visits his ancestors at cemeteries.

This nominee doesn't have the specific background of *Waialua Moku* whereas my Husband as previously learned much from his Grandfather and their family were cultural informants for the Bishop Museum in their publications entitled *Archeology of Oahu* (1933), The Hawaiian Planter (1940) and Sites of Oahu (1962). The Kawaihapai Ohana opposes GM 282. Part of our kuleana is the care of Na Iwi Kupuna within the Waialua Moku with an emphasis along the Northwest Coastline encompassing the Ahupua'a of Kamananui, Mokulei'a, Kekahi, Auku'u, Kawaihapai, Kealia and Kaena which has been done for sometime. The most recent being the disturbance of Iwi Kupuna at Kawaihapai Airfield (Dillingham Airfield).

As a matter of principal, the nominee doesn't reside or is a registered voter in the *Waialua District. Wahiawa* is not *Waialua*. The nominee has not participated as extensively within our community regarding *Na Mea Hawaii* of *Waialua Moku* nor attended community meeting such as the *North Shore Neighborhood Board* where presentations regarding projects that potentially encounter *Iwi Kupuna* are done prior to being on the agenda for *Oahu Island Burial Council*.

The nominee along with organization(s) which included The Office of Hawaiian Affairs halted the Stryker Brigaide project at Haleauau Heiau situated at Lihue without foundation knowledge (mo'olelo) of Lihue. Kalena Kai was composed by King Kamehameha II (Liholiho) and no one knew this except Thomas T Shirai Jr because it's treated as an Ohana mele and speaks of Wahi Pana within Walalua Moku. King Liholiho composed this for the Poe Kanaka of Walalua Moku who were loyal and kokua him with food supplies in 1820 before going to Kauai:

Kalena Kai composed by King Liholiho <u>Verse 2:</u> O ka ehu, ehu o ke kai – The sea spray Ka moena pawehe o Mokulei'a – Geometric designs of the plains of Mokulei'a <u>http://huapala.ore/KAL/Kalena Kai,html</u>

This verse speaks of the Agricultural sustainability of Mokulei'a Ahupua'a and Na Kupuna of Kawaihapai Ohana provided King Kamehameha II with food supplies.

Na Kupuna of Kawaihapai Ohana also were cultural informants of Waialua Moku for the Bishop Museum and featured in their publications entitled The Hawaiian Planter (Handy – 1940), Archeology of Oahu (McAllister – 1933) and Sites of Oahu (Sterling & Summers – 1962). Additionally they were featured in a publication entitled Pana Oahu (Beckett & Singer-1999). The nominee doesn't have this inherited specific knowledge of Waialua Moku.

There are unethical and political discrimantion committed by The Office of Hawaiian Affairs (OHA), State Historic Preservation Division (SHPD) and Governor Lingle's Selection Committee regarding nominees for State Boards & Commissions. Among these are lost or misfilled application, no appropriately affected community input and deviating from the legislative process. There is an attempt thru GM 282 to piggy back and have this nominee serve an additional term from 6/30/08 thru 6/30/12 (four years) without input or nominations. Aole Pono.

The nominee lacks the mo'okuauhau regarding existence in Waialua Moku whereas Thomas T Shiraí Jr is the pono nominee for Waialua Moku.

Na Kupuna of Kawaihapai Ohana have been very active spiritually demonstrating their anger regarding these matters and the hoailona and kaona have included legislation. All surrounds Waialua Moku with an emphasis on Kawaihapai Ahupua'a: 2008 Legislative Session Aloha Airlines Flight 261 (last flight) – Grant 261 (My Home in Mokulei'a)

2007 Legislative Session

GM 276 (Peter Young as DLNR Administrator – Not confirmed) – ACT 276 (Renaming Dillingham Airfield to Kawaihapai Airfield)

GM 279 (Barry Fukunaga as DOT Administrator – Replaced Rod Haraga) – Grant 279 (Ohana Aina where Iwi Kupuna where disturbed at Kawaihapai Airfield)

SCR 260 (Audit of SHPD) -- Grant 260 is situated at Kawaikapai Airfield

Colncidentally, all of this started shortly after Thomas T Shirai Jr was not afforded to serve another term on Oahu Island Burial Council's Waialua Moku Representative. Greetings from Mokulei'a which is an ahupua'a situated on the Northwest Coastline of Waialua Moku where my Wife and I are a homeowner and reside. My Piko is Walalua Moku continuing today as a lifetime resident and I've been entrusted by my beloved Tutu Kane as Kahu (keeper) of our family's Mo'okuauhau spanning at least TEN generations in Waialua Moku.

I strongly oppose GM 282. Before stating my reasons I feel that the State Historic Preservation Division's selection committee regarding nominees for the Island Burial Councils need to attend the Ethics Commission Seminar.

The nominee doesn't reside or is a registered voter in Waialua Moku. Island Burial Councils is a State Board/Commission and therefore should conform and be consistent with legislators representing specific geographical areas. Wahiawa is not Waialua. That is why there was hope in SB 2557 (Relating to Burial Sites) that to ammend requirements for specific geographical representation.

I've also submitted an extensitve application and the contents reflect that I have a better commitment pertaining to this honorable *kuleana*. Furthermore, I've been recognized by the State Historic Preservation Division with descendant recognition several times within *Waialua Moku* and among them I have the distinction of Lineal Descendant three (3) times recgarding *Iwi Kupuna*.

I'm very fortunate to have inherited much of my Hawaiian Cultural and Historical knowledge from my Tutu Kane (David Peahi Keao Jr). My Grandfather and his elders were informants for the Bishop Museum and featured in their publications entitled Archeology of Oahu (McAllister – 1933), The Hawaiian Planter (Handy – 1940), Sites of Oahu (Sterling & Summers – 1962) and Pana Oahu (Beckett & Singer – 1999). Later in the early 1990's the Bishop Museum sent Jeanette Simmons to visit my

During the 2007 Legislative Special Session surrounding the Super Ferry hearings, many State Boards & Commission Gubernatorial Nominees where being confirmed by the Senate prior to their expiration date or also never been approved. Among them was this nominee who is currently serving out the remainder of a previous OIBC member. Please note this nominee filled that position without any recommendation from Waialua Moku. It was passed because the term expires on 6/30/2008. What the Governor and/or the State Historic Preservation was going to do was "piggy back" and have this person serve another 4 year term until 6/30/2012 without and consideration or recommendation from Waialua Moku. I caught this terrible injust towards my community and for some reason her nominee was withdrawn. This is the only way my community and I found out about this and therefore given my backiground filled out an application for State Board and Commission. I've also filled out the Office of Hawaiian Affairs's application for nomination to Island Burial Council. Both applications were done in a very timely manner. The State Historic Preservation and Office of State Boards and Commissions received my application however the application for the Office of Hawaiian Affairs was not acknowledged even though it was presented to the Native Rights Division staff during the Native Hawaiian Historic Preservation Council's meeting and furthermore left out deliberately by staff who was taking minutes of that meeting. EVERY MEMBER of Native Hawaiian Historic Preservation Council who was present witnessed this and when NHHPC had a meeting the following month my application was excluded from the list of nominees for Island Burial Council. The Office of Hawaiian Affairs and Native Hawaiian Historic Preservation Council were well aware that their was going to be an opening on OIBC for Waialua Moku but listed only reference pertaining to Koolauloa.

The current nominee was active only in *Lihue* regarding the Stryker Brigaide which resulted in halting the project. The Office of Hawaiian Affairs sued the Army and the nominee was apart of it. At this time I'd like to share that the nominee, OHA, Iliuokalani Coalition, DMZ-Hawaii and others DIDN'T KNOW THAT A SCARED CHANT PERTAINING WAHI PANA WITHIN WAIALUA MOKU EXISTED AND WAS WRITTEN BY KING KAMEHAMEHA II (LIHOLIHO) THAT INCLUDED LIHUE. The chant is entitled Kalena Kai composed in 1820 by Liholiho when he visited and stopped in Waialua Moku for supplies before continuing to Kauai. He honored Poe Kahiko of Waialua Moku which this appreciation for our Aloha and Kokua. Among those place visited was Mokulei'a and my Kupuna supplied them with mea ai that included kalo:

Kalena Kai (verse 2) by King Kamehameha II (Liholiho) O ka ehu, ehu o ke kai – The sca spray Ka moena pawehe o Mokuleia – Geometric designs of the plains of Mokuleia This is an Ohana Mele and taught to me by my Tutu Kane: <u>http://huapala.org/KAL/Kalena.Kai.html</u> <u>www.huapala.org</u>

I'm listed as the reference and also shows that noted composer Charles E King didn't compose this chant but only set it to music.

Grandfather to update information about Waialua Moku. Thru this great inspiration from my Kupuna, I carry on this by also being recognized as a Cultural Informant for the Environmental Council regarding Waialua Moku. I'm also the Po'o of Kawaihapai Ohana which is recognized as a Native Hawaiian Organization by the Department of Interior. Part of the kuleana (mission statement) is malama iwi kupuna with an overall kuleana of Malama Waialua Moku.

My Ohana prior to the Mahele until shortly after World War II owned several tract of land (Palapala Sila Nui – Land Grants & Land Commission Awards) within Waialua Moku. They were people of rank. I grew up with all of this from my Tutu Kane. I've actively participated in numerous participation regarding Na Iwi Kupuna throughout Waialua Moku and other places on Oahu which includes three (3) cemeteries and (2) Memorials:

> Puuiki Cemetery – Waialua Puea Cemetery – Kalihi Kawaiahao Cemetery – Honolulu Kahi Halia Aloha – Waikiki Iwi Kupuna Memorial Punaluu Jwi Kupuna Memorial

Thru these involvement, I've iniciated some legislation to protect Na Iwi Kupuna. Please note that these involvement were done before and during my tenure serving on the Oaku Island Burial Council's Walalua Moku Representative. During my tenure, I also was apart of OIBC's legislative committee and have a few legislation regarding Na Iwi Kupuna protection with some becoming law.

I also continue to be an active community constituent and activist in my community attending the North Shore Neighborhood Board regularly. Please note that the Neighborhood Board is a great source where cultural and historical projects are presented for they reach Burial Council's. I've been attending these for many years whereas the current nominee has not. I have a petition which every member of the North Shore Neighborhood Board have signed except one supported me to be nominated and serve on Oahu Island Burial Council as Waialua Moku Representative. Additionally the Mokulei'a Community Association sent a letter of support for me as well. These oganizations represent the Community and serve on multiple community organizations also. Furthermore, Waialua District's legislators both Senator Robert Bunda and Representative Michael Magaoay have sent in letters of support and recommendation on my behalf. This was totally disregarded and no reason given just like my current application.

During that time a former member of OIBC was approved and later had to resign because she became an employee of the State Historic Preservation Division (SHPD). Further insult was that the time of her appointment she resided in *AIEA* (continues today) and not *WAIALUA*. Her Ex-Husband is a staff member for Councilmember Donavan Dela Cruz. Regarding this nominee, her Husband is an intern employee at the Office of Hawaiian Affairs in their Native Rights Division. Further remarks about this is that *Lihue* was not really disturbed and it was shared by a reliable source who stated that the buldozed stones were a mere *"blue rock" only*.

Getting back to my Office of Hawaiian Affairs's application, it brought back bad memories regarding my misplaced burial report that my Grandfather, Mother, Wife & I spent an entire afternoon with State Historic Preservation Division Staff and continuing with OHA's Native Land Rights Division which includes as stated the nominee's Husband.

My relationship is so deep in *Waialua*, that my *Ohana Iwi Kupuna* spoke loud and clear with the disturbance my *Kupuna* at *Kawaihapai Airfield* and continuing *hoailona* in the form of legislation to this very day:

April 3, 2008

It is with pleasure that the Department of Land and Natural Resources (Department) recommends Senate confirmation of the appointment of Hinaleimoana K. K. Wong to the Oahu Island Burial Council.

The Island Burial Councils were established under Chapter 6E-43.5, Hawai'i Revised Statues, to determine the preservation in place or relocation of previously identified native Hawaiian burial sites and to determine Hawaiian cultural and lineal descendancy claims for specific burials.

State law requires that Island Burial Councils be established for Hawai'i, Maui/Lanai, Molokai, Oahu and Kaua'i/Ni'ihau islands, and be comprised of representatives from specific geographic regions and representatives of developer/large property owners. 

This discussion was a point of focus in preparation to address some of the shared concerns of community members and specifically the 'Ahahui Siwila Hawaii O Kapolei and its concerns that were prevalent at that time related to proposed mixed use of the Pu'u with multiple stakeholders asserting various rights of legitimacy to access and use this property. I recall that it was through the combined efforts of community leadership and stewardship by Anakala Shad and Kumu Hula John Ka'imikaua that I was humbly privileged to participate in 'aha 'aina conducted at Pu'uokapolei. The essence and details of how this ceremony was carried out is not meant for elaboration in this type of communication. However, what is important to share is that this was one of my many learning experiences as to how to invoke traditional cultural practices and values and convey them contemporarily as a means to facilitate and seek a kahua (foundation) from which community dialogue can appropriately commence and be engaging.
