

Chair English and Members of the Committee:

My name is Barbara Kim Stanton, State Director for AARP Hawaii. We are a membership organization for people 50 and older with 156,000 members in Hawaii. AARP provides access to services and information, meaningful volunteer opportunities, and the opportunity for our members to create positive change in their lives.

While we do not oppose Mr. Brennon's appointment as Director of the Department of Transportation, we do have some concerns and hope that we can see improvement based on our past experience.

We believe that the Director of Transportation should take grassroots concerns seriously and be more responsive. Mr. Brennon, as deputy for the department, was the point person for SB 1191, Relating to Pedestrian Safety, and disappointingly, did not support Act 10, SLH 2007. While we can understand a difference of opinion on funding, we are concerned that laws should not be ignored just because the Administration disagrees.

The Governor vetoed SB 1191 and the legislature overrode the veto. As such, DOT should have funded the \$3 million from the Special Fund to provide monies for a statewide pedestrian safety campaign.

We look forward to working with Mr. Morioka. We believe that he can be more receptive to citizens concerns. We hope that he will reprioritize transportation issues to make streets safer for pedestrians too, not just for vehicles.

This testimony is in support of the confirmation of Mr. Brennon Morioka as the Director of the Department of Transportation (DOT). The Hawaii Bicycling League is a non-profit, membership organization dedicated to promoting cycling for health, recreation and transportation through advocacy, education and events.

For the general public, the process of transportation planning and maintenance is a highly complex, confounding and frustrating process. It is difficult to understand the numerous funding streams, technical engineering details, and often vague decision-making criteria and justifications. It is a challenge for any citizen to comprehend, let alone influence. Moreover, the organizational culture at DOT, dominated by engineers, does not often encourage working with community organizations and does not always provide information in a manner that allows for informed public participation. Indeed, it is not unusual for HBL to confront open opposition from DOT engineers who may consider bicyclists and pedestrians as impediments to the efficient movement of motor vehicles.

Since Mr. Morioka's appointment to DOT as Highways Deputy, HBL has found someone who has a genuine interest in pursuing multi-modal transportation and enhancing bicycling. He has encouraged and directed our participation toward mutually productive outcomes, provided information that helped our members' understanding of the process, and provided clear justifications when our requests could not be accommodated. Despite the incredible demands on his time, HBL has always found Mr. Morioka to be responsive and accessible to our inquires and requests. Although progress and change has been slow to come, HBL has found Mr. Morioka to be a valuable partner who is truly respectful and considerate of community input.

With Mr. Morioka's confirmation it is HBL's hope that DOT will continue to:

- Recognize and proactively support multi-modal transportation, including bicycling and pedestrian
 options.
- Support community bicycling advocates' concerns and implement provisions of the State Bike Plan.
- Encourage more public collaboration with DOT staff to assure effective service provision and improved bicycling/pedestrian infrastructure.
- Support greater public participation to develop bicycle improvements through the transportation planning process (i.e. OMPO, Statewide Transportation Improvement Plan, project EIS).
- Continue to work with statewide bicycling and pedestrian advocates including the Hawaii Bicycling League (add Maui group & may be others in the HB 497 legislation).

HBL looks forward to continuing our work with Mr. Morioka to make our streets safer and make Hawai'i a more desirable place to bicycle and live. We are committed to continue our collaboration with DOT under Mr. Morioka's leaderrship and are hopeful that this partnership will result in real improvements to Hawai'i's roadways.

We strongly support the confirmation of Mr. Morioka as Director of the State Department of Transportation.

My name is Ben Tsukazaki. I am an attorney in Hilo and have represented clients in various matters involving the Department of Transportation.


