Clearly Mr. Shintani is someone who embodies the spirit of the credit union movement and is actively working to realize the credit union mission within his community. Oahu One Credit Union is one of the two state-chartered credit unions in Hawaii, so Mr. Shintani is very familiar with the state laws and rules governing state-chartered credit unions and is well qualified to fulfill the duties of a member of the Credit Union Advisory Board.

G.M. No. 303, Wayne Minoru Shintani, Nominee to the Credit Union Advisory Board

My name is Mike Leach, Legislative & Regulatory Affairs Manager for the Hawaii Credit Union League (HCUL), the local trade association for Hawaii's state and federally chartered credit unions. I apologize for not being able to be personally present today to ask for your favorable consideration of the nomination of Wayne Shintani to the Credit Union Advisory Board.

Section 412:19-125, *HRS*, sets forth general criteria for serving on the Board: "...persons of tested credit union experience and who are members of credit unions operating under this chapter."

Wayne far exceeds this general criteria, evidenced in part by being nominated for his third, non-consecutive, term as a Board member. He has over 22 years of experience with Oahu One Credit Union, one of two credit unions chartered by the State. He is the credit union's assistant manager. Although his primary area of expertise is in the area of loans, he is responsible for the daily operation of the credit union. I understand that Wayne may not be able to be present today, due to operational requirements at the credit union and a prior, long-standing committee staff of his probable absence and to make himself available to otherwise respond to any questions or concerns.

I respectfully request your strong support for Wayne's nomination.
