
It is with great pleasure that I am writing to support the nomination of Kitty Lagareta for the Board of Regents of the University of Hawaii.



I am writing in support of Kitty Lagareta's nomination for the University of Hawaii Board of Regents.

I have know and worked with Kitty Lagareta since January, 2002. Kitty was one of the leaders who resurrected the Oahu Economic Development Board in the mid 1990's, transformed it into Enterprise Honolulu and convinced me to come to Hawaii. Kitty has served on the Enterprise Honolulu Board since 2002. (The attached recent article about Hawaii's success in creating new technology companies and jobs -- 4th in the U.S.-- offers some testimonial support for Kitty's vision.)

One of the biggest challenges and opportunities facing Hawaii is to integrate the UH system more into the community as one of the state's major resources not just to ensure world class education for Hawaii's young people, but to also tap the considerable intellectual knowledge, experience, global contacts, technology R&D that resides in the UH to more directly help solve Hawaii's social and economic challenges and to seize new opportunities.






I am writing in strong support of the confirmation of Kitty Lagareta for the Board of Regents at the University of Hawaii.
