TITLE: RELATING TO DRIVER LICENSES.

DESCRIPTION:

PERMITS THE EXAMINER OF DRIVERS TO WAIVE THE KNOWLEDGE TEST FOR AN APPLICANT REAPPLYING FOR A HAWAII DRIVER'S LICENSE WHERE THE APPLICANT HOLDS A VALID LICENSE FROM ANOTHER STATE OR TERRRITORY AND THE APPLICANT'S PRIOR HAWAII LICENSE WOULD HAVE EXPIRED NOT MORE THAN ONE YEAR AFTER THE DATE OF THE REAPPLICATION.

DEPARTMENT'S POSITION:

The Department of Transportation (DOT) supports this bill.

COMMENTS:

Current law already allows drivers with a valid license from another state to drive on our roads. The bill does not appear to compromise a traffic safety issue. Many states waive all testing if the applicant has a valid driver's license issued by another state and the validity of the person's driver's license can be verified electronically.
