Chair Oshiro, Vice Chair Lee, Honorable Members, et al:

The purpose of this measure is to establish a legislative protocol fund to welcome and extend diplomatic courtesies to visiting distinguished visitors (DVs) and heads of state.

I strongly support this measure on the basis that Hawaii's geographic position makes it America's frontline state for international diplomacy and engagement. Thinking strategically towards the future, Hawaii has the opportunity to serve as a location to host diplomatic summits, international economic meetings, and even serve as a neutral location for other countries to hold negotiations. To accomplish this, it is extremely necessary for a protocol fund to exist to support interaction between our local government and those governments which choose to engage Hawaii.

Critics of the protocol fund have often derided it as nothing more than a "padded expense account" or a "legislative slush fund" but nothing could be farther from the truth. This fund's purpose is to allow Hawaii to engage our international community on a level that is commensurate with the long held international tradition of receiving dignitaries and heads of state in a hospitable and dignified manner.

I would be very impressed if Hawaii were to be the site of a future G-8 summit, or if, in the future, Hawaii was the site of the signing of a major arms control treaty or peace treaty. I believe that establishing this legislative protocol fund is the first step towards realizing that dream, and I strongly urge the members of the House Committee on Finance to pass this measure.
