HB 2134 HD2, Relating to the Center for Nursing

Chair Oshiro, Vice Chair Lee, and members of the House Committee on Finance, thank you for this opportunity to provide testimony in support of HB 2134 HD2, Relating to the Center for Nursing. We support the intent of this bill which amends Act 198 by extending the sunset date by one year for the deposit and disbursement of the center for nursing special fund. However, a five year extension to 2014 is critical to allow the continuation of projects currently underway and time to explore best practices for funding of Centers for Nursing.

University of Hawai'i at Mānoa is privileged to provide a home for this successful and vital Center established by the 2003 Legislature. Since becoming operational in May 2005, the Center for Nursing efforts have benefited state policy makers, nurses and healthcare. The Center has contributed significantly by:

- Providing a venue to focus on the nursing workforce; supporting the executive and legislative branches of state government to inform policy development
- Convening nurses from all sectors to come together to improve quality of care and health outcomes for Hawai'i residents
- Conducting rigorous surveys whose results inform policy development and resource allocation regarding the state nursing education and workforce capacity
- Establishing innovative partnerships to improve recruitment and retention of nurses in the long term care setting
- Developing and conducting the first prospective 5-year study to document new nurse employment and career patterns.

Specifically, the Center's annual survey of state educational capacity is critical to the UH Mānoa and statewide nursing consortium efforts. Data driven state level evidence on

enrollments, graduations, programs and faculty demographics ensure that efforts to increase the pipeline of Hawai'i's nursing workforce and nursing faculty reflect state need.

It is imperative that the Center for Nursing continue its efforts on these complex issues. Due to their efforts, Hawai'i has a data and evidence driven description of the nursing workforce. As we identify trends and impacts, we are generating policy and funding efforts targeted to our state need. Extension of the sunset clause is required to assure the Center can complete its work in establishing a portrait of the Hawai'i nursing workforce, our ability to prepare for state need, and successful efforts to sustain the nursing workforce here.

As authorized in the 2003 legislation, funds to operate the Center are generated by fees collected upon nurses' biannual licensure renewal. The State Treasury provided funds to the University by creating the Center for Nursing Special Fund. We note that there is discussion in the 2008 Legislature regarding the support for the existing fee assessment. A survey of 10 other state centers indicates that several approaches are used to fund such Centers. Three states have a surcharge; one allows nurses to elect the fee at license renewal; and one transfers monies from license fees. Three are funded via recurring state appropriations; one by private foundation; and one by hospitals.

In summary, the University of Hawai'i Mānoa recommends amending HB 2134 HD 2 by providing for a sunset extension to 2014 and conducting a review of best practices for funding of Centers for Nursing. We believe this approach allows the Center to continue its work in progress as noted above.

TO THE CHAIR OSHIRO AND MEMBERS OF THE COMMITTEE

My name is Patricia Lange-Otsuka and I am the Interim Dean of the School of Nursing at Hawaii Pacific University. I appreciate this opportunity to present testimony in support of House Bill No. 2134 H.D. #2.

The purpose of this bill is to extend the sunset clause for the present funding for the Hawaii State Center for Nursing (HSCN) from 2009 to 2010. However I would support a longer extension of the clause until 2014 to allow the adequate time to explore and seek other means of funding their work.

I support House Bill No. 2134 because:

• The data and evidence collected by the HSCN is invaluable in making workforce, policy and resource decisions. This information is well worth the costs bore by the nurses in this state to support the HSCN. The fee is funds well spent related to the outputs achieved by the HSCN. These items include an annual projection of the supply and demand for nurses, fact sheets on the nursing shortage, an annual survey and report on the nursing education capacity within Hawaii, and a five year longitudinal study of new graduate retention in the Hawaii workforce.

- The HSCN is currently affiliated with 33 other state centers for
 nursing that are doing vital work on workforce development, nurse
 retention, supporting nursing education and access to education in
 nursing. The ability to share and collaborate for good data and
 outcomes is essential not only to our community but the greater good.
- It provides a non-partisan entity that brings together different and varying stakeholders in a comprehensive way to address and develop plans of action to the issues of patient safety, quality of care and access to nursing education. HSCN has organized and hosted two summits on Education and Practice, the most recent in December 2007.
- HSCN took the lead in the development and successful grant writing for a collaborative partnership between HSCN, HMSA, four local schools of nursing and four long term care agencies to enhance the student nurses experiences in long term care; work to develop a career trajectory for the nursing staff; facilitate continuing education for the long term care staff; and to foster leadership/career development to sustain this expanding workforce.

Testimony in support of HB 2134 HD 2.

I am Rich Meiers. President and CEO of the Healthcare Association of Hawaii, which represents the entire spectrum of health care, including acute care hospitals, two-thirds of the long term care beds in Hawaii, as well as home care and hospice providers. Thank you for this opportunity to testify in support of HB 2134 HD 2, which extends the sunset provision of the funding mechanism for the Center for Nursing.

When the shortage of nurses was first identified as a serious problem, the information needed to address the problem was incomplete, scattered, and sometimes conflicting. As a result, decisions to increase the supply of nurses could not be made with much confidence. So the Legislature passed Act 198. SLH 2003, to create the Center for Nursing, which has been tasked with the following functions:

- Collect and analyze data, and make recommendations regarding the current (1) status and trends of the nursing workforce;
- Conduct research in best practices and quality outcomes; (2)
- (3) Develop a plan for implementing strategies to recruit and retain nurses; and
- (4)Research, analyze, and report data related to the retention of the nursing workforce.

Since its inception, the Center for Nursing has engaged in a variety of research that provides a greater understanding of the nursing workforce, including: (1) Nurse turnover and retention; (2) Nurse employer demand; (3) A longitudinal study of new graduates; (4) A forecast of Hawaii's nursing workforce until 2020; and (5) Recruitment and retention of nurses in the long term care sector. In addition, the Center for Nursing has issued reports on nurse education programs in Hawaii, nurse education and practice, and the state of the nursing workforce.

The Center for Nursing has demonstrated its value in gathering and analyzing data that is essential to creating sustainable solutions that are specific to Hawaii's nursing workforce shortage. Previously, we were reliant upon national data and trends that did not correlate well with Hawaii's conditions.

The sunset provision for the funding mechanism for the Center for Nursing was included in Act 198, SLH 2003, to ensure that a proactive effort would have to be made to continue the activities of the Center for Nursing. The Center for Nursing has clearly proven its value.

For the foregoing reasons, the Healthcare Association strongly supports HB 2134 HD 2.

We offer specialized care in the areas of cardiology, neuroscience, orthopedics, behavioral health, oncology, women's health, emergency services and trauma. Aloha and thank you for this opportunity to provide testimony in support of HB 2134, H.D. 2. I am Dr. Jane Kadohiro, a nursing faculty member, an active volunteer in health issues in the community, and a member of the Hawaii State Center for Nursing Board. I am also a member of the Hawaii... and the American Nurses Association.

While I support the intent of this bill which extends the sunset clause for the Center for Nursing for one year, I urge you to pass the earlier proposal which extends the sunset for five years, until 2014. The Center has made significant contributions to address what is not just a temporary shortage. A long range plan has been developed to address both the long and immediate shortages. Many community stakeholders representing a broad range of Hawaii's people and professionals who are and will be impacted by the shortages have worked tirelessly to develop programs and activities which are in various stages of development. Many of these plans will not likely progress to implementation, should the Center funding be stopped in the time frame proposed by HB 2134, H.D.2. This would seriously halt the significant progress that has been made to date- and in a short period of time.

The Legislature first established Hawai'i State Center for Nursing in 2003 to address issues related to the nursing shortage we face and particularly those issues surrounding recruitment and retention of registered nurses and nursing faculty.

Specifically, the charges were to:

- 1. Collect and analyze data regarding the current and future status and trends of the nursing workforce
- 2. Conduct research on best practices and quality outcomes
- 3. Develop a plan for implementing strategies to recruit and retain nurses, and

4. Research analyze and report data related to the retention of the nursing workforce

Our Board became actively engaged in establishing an infrastructure and in developing a strategic plan from the beginning of our existence. The Center became incredibly productive once we were able to hire an executive director and a small, yet outstanding staff, shortly thereafter. The work of the Center for Nursing has benefited nurses at all levels of nursing and all settings, policy makers, and the wider healthcare community with its facilitation of many stakeholders throughout the state ((nurses, many other disciplines, business, etc) who have become active participants in the work groups and committees staffed by the Center.

It is very clear that every aspect of the mandate has been addressed. Good afternoon Chair Oshiro, Vice Chair Lee, and members of the Finance Committee. My name is Claudine Tomasa. I am a Registered Nurse and I am testifying in support of HB 2134 HD#2 which extends the sunset clause of Act 198 to expire in 2010 instead of the original date of 2009.

The one year extension of the sunset clause will provide time for the CFN to find alternative funding and to conduct research that will actually help retain qualified, seasoned nurses in Hawaii's hospitals. Many qualified, seasoned nurses have left bedside nursing or have cut their hours of work because of the <u>poor Working Conditions</u> which directly impacts <u>Nursing Practice</u> and a Nurse's ability or inability to provide safe, quality, patient care. This mass exodus is a major contributor to the Nursing Shortage for which the CFN has failed to address during its three to four years of existence-funded by nurses, in which a majority of whom practice direct patient care at the bedside.

With the above being stated, I request that HB 2134 HD2 be passed by your Committee and that the CFN be tasked to provide a comprehensive report- with actionable solutions- to the Legislators on data gathered from all Medical Facilities in the State of Hawaii during the last three years to include but not be limited to:

- 1) Unfilled vacant RN positions in Hawaii's hospitals.
- 2) Use of mandatory overtime to staff nursing units.
- 3) Number of work related muscular skeletal injuries suffered by nurses at the bedside,
- 4) Number of patient related outcomes, i.e. patient falls, postoperative infections, stage IV skin ulcers, medication errors.

Thank you for this opportunity to provide testimony regarding HB 2134, H.D.2, Relating to the Center for Nursing. I support this bill which would extend the sunset clause from 2009 through 2010, however I would urge you to consider a five year extension to 2014. The five year extension is critical to allow continuation of many programs which are currently underway at the Center and the time to explore additional means of funding for future work. Interruption of program activities and data collection would impact the efforts to alleviate the nursing shortage and to improve the retention of practicing nurses.

I have personally been involved in many activities with the Center for Nursing, that have directly addressed the mandate given the Center by the legislature.

- Participation in the survey in collaboration with the Board of Nursing on supply and characteristics of Hawai'i registered nurses
- Utilization of the annual fact sheet on the nursing workforce to educate and inform policy makers and stakeholders about the issues
- Participation in the Nursing Workforce Summit with colleagues from our healthcare community who came together to strategically plan for the future of nursing in Hawaii
- As a nursing faculty member, participated in recruitment meetings with other stakeholders, to implement activities where the Center took an active part in recruitment of students into the profession in Hawaii.

In light of an ongoing nursing shortage in the state and the nation, it is vital that the Center for Nursing continue its efforts to support nurses who are generating Hawai'i specific solutions. Providing for a five year extension to 2014 will allow this valuable and beneficial work to effect a strong nursing workforce into the next decade.
