HOUSE BILL NO. 2417 RELATING TO AGRICULTURE COOPERATIVES

Chairperson Yamashita, Chairperson Tsuji and Members of the Committees:

Thank you for the opportunity to comment on House Bill No. 2417. The purpose of this bill is to establish a process for the planning and establishment of a statewide agricultural cooperative. The Hawaii Department of Agriculture (HDOA) offers the following comments.

The Agricultural Development Division (ADC) has the expertise to manage complex projects like this, but would face resource challenges to efficiently manage the planning and implementation process. Additional staffing and funding would be needed to support the project. The project itself needs to be defined so that its scope has congruous rather than conflicting parts. Further, the scope should be evaluated for the likely extent of companies joining the cooperative and the expected cost to these companies for the services and functions to be provided by the cooperative.

HOUSE BILL 2417 RELATING TO AGRICULTURAL COOPERATIVES

Chairpersons Yamashita and Tsuji and Members of the Committees:

The Agribusiness Development Corporation (ADC) supports the intent of House Bill 2417, provided that its passage does not replace or adversely impact the priorities in the Executive Biennium budget. We believe a state-wide agricultural cooperative could be beneficial and will provide the coordinated effort required for the industry to address marketing, distribution, and transportation issues.

We want to comment that by definition a cooperative is a private entity managed by its members and normally funded by providing services to its membership. However, it is likely that much public funding is needed to support a cooperative of this nature at the beginning. It would also be necessary to

clearly define the intended membership of the cooperative. A cooperative consisting of diverse producers, on dissimilar lands, with varying access to water, transportation and markets, would not have a well defined focus and would be difficult to organize and manage.

We recognize that House Bill 2416 requests a similar task be undertaken by the Department of Agriculture. If the Legislature decides to have ADC take on this task, we wish to point out that the ADC is a small agency with a staff of three employees and has no personnel resources readily available to handle added responsibilities. In addition to managing our existing irrigation systems and agriculture lands, we have recently added the Kau irrigation system and the Kalepa agriculture lands to our list of major, on-going projects. In order to accomplish this task successfully, we respectfully request that: (1) a special assistant position be added to the ADC staff to assist with this project and other tasks, (2) funding to support a consultant and related expenses, and (3) to move back the reporting date to the Legislature from December 31, 2008 to December 31, 2009.

Few have succeeded but many have failed or are struggling. We support the concept of cooperatives, however, are concerned that understanding of why cooperatives have not succeeded in Hawaii must occur. HB2417 provides for planning of the cooperative. We urge that greater emphasis be undertaken to understand the failures of the past and how they can be minimized in the future.
