Dear Chair Ito and Committee Members:

My name is Stuart Coleman, and I am the Vice Chair of the Surfrider Foundation's Oahu Chapter. I am writing to urge you to support passage of HB 2518 because this bill will help in our efforts to reserve more land for the public, including the purchase of the lands at Kawela Bay.

As development and urban sprawl increase, concern about the future of land use and its relation to Hawai'i's natural resources, economy and heritage have come to the forefront of community concern. Some of these concerns are protected and embodied in recent laws providing funding for the acquisition of private lands for public conservation purposes. The recent State Legacy Lands Act is but one example. Funding from programs such as the Legacy Lands Conservation Program yield great benefits to the people of Hawai'i, but further incentives are necessary to provide alternatives to the tremendous financial pressures to convert needed agricultural or conservation land to other uses that generate greater revenue. It is also impossible for the government to acquire and take care of all of these lands.

HB 2518 provides a voluntary incentive for private landowners to protect our precious lands and offers an alternative to acquisition and government management. It advances conservation by creating a competitive class of land use in an economy where conversion by private landowners to other uses are an attractive or economic necessity. I urge you to support HB 2518.

HB 2518 HD1 - RELATING TO LAND CONSERVATION SUPPORT

Aloha, my name is Shannon Wood, speaking on behalf of the *Windward Ahupua'a Alliance*, a 501c3 Hawai'i non-profit corporation, which was established in July, 2002, to create the Ko'olau Greenbelt & Heritage Trails System in order to restore, protect & provide public access to the *mauka* (mountain) lands on the Windward side of O'ahu along the base of *Na Ko'olau* up to the North Shore and Kawela Bay as well as to support locally-owned sustainable economic activities in the more developed areas. Over time, however, its mandate has expanded well beyond these vitally important regional issues.

Too often, conservation lands are purchased with the new owners' intentions of going through land use designation changes in order to make huge profits. I know of one piece of land with a mix of conservation and AG-1 designation in Windward O'ahu which was purchased in 2001 for \$11.5 million whose owners plan to subdivide into five-acre lots once the development moratorium expires which could result in a gross profit of well in excess of \$100 million.

WAA supports <u>HB 2518 HD1</u> because it will reward private landowners for doing the right thing.

HB 2518 HD 1 provides a tax credit to encourage the preservation and protection of conservation land in the State. We emphasize that our testimony on this measure does not represent an official position of the University of Hawaii.

We agree with the intent of this bill. Tax credits have been used in other states very effectively to conserve land. This practice can potentially save the state millions when trying to preserve conservation lands as it will allow the state to choose whether or not to purchase all the land it wishes to preserve. This can work to the state's benefit especially when leveraged with NGO or Legacy Land Conservation Commission funds to preserve trying to preserve contiguous tracts of land.
