### **Testimony in Support of HB 2543, Related to a Public Shooting Range on the Island of Hawaii**

Dear Chairs Evans and Ito, Vice-Chairs Har and Karamatsu, and Members of the Public Safety & Military Affairs Committee and the Water, Land, Ocean Resources & Hawaiian Affairs Committee:

I am a volunteer member and have been requested to speak on behalf of the Hawaii Island Public Shooting Range Working Group, a private citizen/ public agency partnership engaged in a cooperative effort to develop a public shooting range on the Big Island.

Our four-year long, grass roots-led effort to address the absence of an island shooting range has made significant progress. We have completed the conceptual design of a facility that would accommodate all user needs, and selected a location that is ideally situated for such a purpose. We have actively sought the participation of all who may have an interest or concern in the project, and community support thus far has been overwhelmingly positive.

In 2007 we received Land Board approval to proceed with the planning activities necessary to develop a shooting complex in the Pu'u Anahulu Game Management Area, adjacent to the county landfill in west Hawaii. To keep the project moving forward, we need to prepare an Environmental Impact Statement, develop a Facility Master Plan, and complete infrastructure modifications that will allow us to share landfill access. It is for this purpose that we are seeking financial assistance.

The Hawaii Island Public Shooting Range Working Group has made a significant effort to advance this project to its current status, and we gratefully acknowledge the assistance and cooperation of state and county agencies, local businesses, state-wide hunting and shooting clubs, and the people of Hawaii. With your help we can, and will complete the task of providing a safe place to shoot for the residents and visitors of our island.

We respectfully request that you pass HB 2543.

Dear Chairs Evans and Ito, Vice-Chairs Har and Karamatsu, and Members of the Public Safety & Military Affairs Committee and the Water, Land, Ocean Resources & Hawaiian Affairs Committee:

My name is Richard Hoeflinger. I have been involved in a 20-year long effort to establish a public shooting range on the Big Island for the past 8 years. I am a founding member of the Hawaii Island Public Shooting Range Working Group which was formed in 2004.

A lifelong hunter, I can speak to the handicap island hunters face with lack of a designated venue to sight in firearms and develop the marksmanship skills essential to the humane taking of game. The proliferation of informal shooting sites around the island has raised growing concern among many of us over related safety issues and the increasing accumulation of debris on public lands.

In the years I formerly resided on the mainland, I was a competitive shooter in all disciplines: rifle, pistol, and shotgun. Lack of a multi-purpose shooting facility on the island now limits my participation solely to the latter. Competitive shooting is noted for its enviable safety record and ability to engender discipline, purpose, and commitment in participants, young and old alike. I share with others the sorely missed opportunity to engage in competitive rifle and pistol shooting that I so enjoyed in the past.

As a veteran Hunter Education Program instructor, I am concerned with the dichotomy of a state-mandated program for instruction in safe firearms handling and marksmanship training for new hunters, and the corresponding absence of a facility in which to conduct such a program. A former police officer, I also recognize the disadvantages our law enforcement personnel face with lack of a suitable facility in which to conduct training programs and routine firearms qualification exercises. The shooting facility we have proposed addresses all of the aforementioned concerns.

The Shooting Range Working Group, whose volunteer membership includes citizen and law enforcement user groups, state and county government agencies, related businesses and adjacent neighbors, has completed the conceptual design and site selection for a multi-purpose shooting complex on state land in west Hawaii. A preliminary sound survey has been conducted that suggests no adverse impact on surrounding property owners, and successful negotiations have been held to share site access through the adjacent county landfill. Land Board approval was received last year to proceed with planning activities associated with the designated site use. We now need some financial assistance to carry this effort forward.

I respectfully urge the Committee to pass HB 2543, which will support preparation of an Environmental Impact Statement and other planning activities required for this much needed public shooting facility.

Dear Chair Evans, Vice Chair Har, and Members of the Public Safety and Military Affairs Committee:

I am totally in favor of bill HB 2542 and urge you and your peers to support this bill so that it will come out of committee during the meeting on February 14, 2008.

I own several registered firearms, as does my adult son. When a public range was available, we would have the opportunity to spend precious time together target shooting, which is an activity we both have great interest in.

When the North Kohala range was open, we would glad drive a combined 160 miles during that day to spend time with each other and to meet other like-minded, skilled, marksmen.

My adult daughter would also accompany us and hone her skills and gain familiarity with these tools. And again, this gave us a good chance to get together from our areas of the island, enjoy the outdoors, meet good people with disciplined skills and share a picnic lunch in good spirits and good company.

I first learned to respect and handle firearms as a Boy Scout in the late '50s. While serving out country during the Vietnam War, my respect, knowledge and familiarity with other firearms was broadened. I have instilled these traits in my children.

While living in Connecticut, the family would often visit the local ranges (indoors in winter - brrrrr). In Connecticut, I study and practiced and qualified for a permit to carry, which made it very convenient to bring my firearms to my local repair facility, to the police station to register, to the local public ranges and to friends houses in the country where discharging a firearm was permitted.

People will, and do, own firearms. If they are not given a place to practice safely, how can they learn? If they are not given a good environment to meet others with greater skill, how can they learn to respect their firearms.

Please supprt this bill and promote it's passing. By doing so you will promote a sport that many enjoy. You will be encouraging development of disciplined clubs that will promulgate proper technique and safety. And you will be giving our neighbors and friends an activity that they can share with their families.

I commend you on introducing H.B. No 2543 and fully support all efforts to implement a dedicated area for those of us who enjoy recreational and competitive shooting. Currently, there is not a dedicated public shooting range. Not having a public shooting range has prompted individuals to partake in discharging their weapons in areas that are meant for hunting. This not only increases the possibility of injury but also destroys both the integrity of hunting and the surrounding flora and fauna.

The construction of a shooting range in West Hawai'i can be very beneficial in a number of ways.

For example:

- 1) A safer environment will be available for shooters of all ages.
- 2) Shooting competitions will attract not only area residents but out of state competitors and will bring more revenue into Hawai'i. This can be evaluated by researching the competition held on Oahu every September.
- 3) Weather conditions are favorable in West Hawai'i compared to East Hawai'i, although having a range on the east side of Hawai'i would be nice.
- 4) Less destruction to the endemic flora and fauna of Hawai'i by illegal firearms discharge.
- 5) Integrating instructional sessions or lessons on how to handle firearms safely and correctly by trained professionals may lessen accidents.

Dear Chair Evans, Vice Chair Har, and Members of the Public Safety and Military Affairs Committee,

I would like to voice my support for House Bill 2543, which would create a public firearms shooting range in West Hawaii. It is my understanding that the Committee will meet to discuss this Bill this Thursday, Feb. 14, 2008 at 10:55AM.

I am an owner of several firearms which I enjoy shooting for recreation. Currently there is no legal place in West Hawaii where gun owners/hobbyists can go to shoot. For me this means that I have not been shooting for a very long time and, as an old retired guy, I miss not being able to enjoy this hobby. But, more importantly, I believe that not having a legal and safe place to shoot is undesirable for several reasons:

First, Many people own firearms in Hawaii. I believe that many of them currently go shooting both for recreation and to practice for hunting and I am concerned that safety may be being compromised as various individuals select unapproved places that they feel are "safe" to discharge their firearms. Hawaii Island is large but the population continues to grow. As time goes on it will become increasingly unsafe for individuals to discharge firearms at times and places of their choosing. An approved site for public shooting selected and designed by experts will insure safety for all residents of the Big Island.

Even though the State requires and provides the excellent Hunter Safety Training Program for gun owners, It does not teach "hands on" training for shooters nor provide a place to do this. I believe as a result, we have lots of people (and in many cases their children) out hunting and shooting who are unfamiliar with their guns and safe firearm handling procedures. An approved shooting site will allow the opportunity for organized gun safety training and familiarization.

Hawaii has strict laws regarding the ownership and use of firearms of which I am very supportive. We now need to take the necessary step of providing citizens with a safe place to use their guns to insure we achieve the safety benefits that current laws and required training are designed to promote. Thanks for your time.

On behalf of the Hawai'i County Council, I ask you to pass House Bill 2543. House Bill 2543 appropriates funds to plan, design, and construct a shooting range in West Hawaii.

There aren't any shooting ranges in West Hawaii. Police, conservation officers, sheriffs, security guards, hunters and others licensed to carry guns have no official place to practice with their firearms. Shooters currently have to find unofficial, unsupervised sites to shoot. Safety of the shooters and individuals in proximity to these sites is of great concern. As the population continues to grow, so does the problem of uncontrolled discharge of firearms.

Members of the West Hawaii community have formed the Hawaii Island Public Shooting Range Working Group. This group is composed of police officers, DLNR conservation officers, other DLNR representatives, hunters, representatives of the Governor's office and the Hawaii County Mayor's office, and other community representatives. The Hawaii Island Public Shooting Range Working Group has come up with a site location, by the West Hawaii solid waste facility, and preliminary plans for a public shooting range. Representatives of the Department of Land and Natural Resources have indicated that \$250,000 would be needed to prepare and EIS and other tasks associated with creating a master plan for this project.

The Hawaii County Council is aware that Mayor Kim has requested your support of this project. The Hawaii County Council supports that request.

We humbly ask you to pass HB 2797.

Dear Hawaii State Representative,  
I implore you to support House Bill number 2543 introduced by Cindy Evans (D-7) for a public shooting area in West Hawaii. This bill will help to protect the community from errant rounds fired in backyard or makeshift target areas that can go anywhere after leaving a gun barrel. This effort will allow law abiding citizens who hunt or shoot recreationally to accurize their weapons and lessen the wounding of game animals or missing of critical shots in competition.

In spite of some opinions to the contrary it would also provide a place for law enforcement officers to keep shooting skills at the highest levels to protect the community and reduce injuries to innocent bystanders in those lethal force, hostage and kidnap situations often faced by our law enforcement community. Some folks think policeman and women shouldn't practice those skills but that is a ludicrous idea.

Hunting also is a bona fide and proven method for reducing numbers of feral ungulates that can decimate native habitat areas when left uncontrolled. Privately guided and public hunting provide an economic driver for habitat management that has been used nationwide to control animal numbers, protect habitat and bring needed dollars to rural communities.

Please vote favorably for this safe place for the shooting sports in West Hawaii.



February 14, 2008

House Bill 2543 appropriates an unspecified amount of funds to the Department of Land and Natural Resources (Department) to plan, design and construct a shooting range on the Island of Hawaii. The Department acknowledges its supports for the establishment of this public shooting range, as the Department has been working closely with community members on Hawaii to accomplish this goal. The Department however is unable to support this measure at this time due to the decrease in the revenue projections (by the Council of Revenues) which will likely have a fiscal impact on the Executive Supplemental Budget request.

The Department supports providing additional staff and funding resources for the Department's Division of Conservation and Resources Enforcement branches across the State and the Department has been working closely with the Legislature to obtain the necessary funds for this broader initiative. And while the Department applauds the intent of this bill, the Department must be mindful that all our islands are crying out for additional enforcement. Rather than passing out this measure, the Department respectfully asks for the Legislature's support of the addition of eleven conservation and resources enforcement positions and four clerk typist positions for deployment statewide to each of the four counties as identified in the Department's supplemental budget request. These additional positions would increase needed staffing statewide and would help improve conservation enforcement capabilities in each of the four counties.

Thank you very much for hearing HB2543. I have read the bill and speak in strong support of it.

As a lifelong resident of and former four-term county council member from the North Kona district, I know firsthand of the need for and strong interest in a public shooting range in West Hawaii, where no such facility currently exists.

For this reason, Hawaii Island residents, including myself, have been personally involved in ongoing public-private community efforts to bring this project to fruition for over 10 years. For the last 4 years, a diverse number of us have served, and continue to serve, as volunteer community members on the Hawaii Island Public Shooting Range Working Group, which is currently spearheading and coordinating the current efforts. Today, however, my testimony is being submitted on my own behalf.

By way of background and in support of passing this bill, it is important to note that:

1. A suitable site for the range already has been selected and set aside by the DLNR Land Board.
2. A draft conceptual layout for a facility to accommodate anticipated and desired resident, visitor and public safety agency uses has been completed.
3. Plans to coordinate existing roadway access points and utilities within the adjacent County Puuanahulu landfill site with those needed for the proposed shooting range are underway.
4. Thanks to the Federal Pittman-Roberts program and considerable volunteer community efforts, matching and in-kind funding opportunities are expected to augment the requested funding.
5. Favorable responses and support for the project have come from diverse community and business groups, and relevant public agencies, as well as Mayor Harry Kim himself.
6. The development of a public shooting range in West Hawaii is vital for firearm training and safety needs of present and future generations of residents, visitors, and public safety personnel.
7. Passage of this bill will provide necessary funding to move this project to the next stage.



I am in East Hawaii and we have a dedicated range in Glenwood for the members of the Big Island Gun club, of which I am a life member and past president, as well as an NRA instructor and NRA certified Master Range Safety officer. I strongly support the creation of a range in West Hawaii, as well as any other measures which support legal and safe gun ownership and use, including a "SHALL ISSUE" law by the legislature, a fifteen round pistol magazine capacity for pistols designed by the manufacturer to hold fifteen rounds and the end of silly legislation like serializing ammunition, which will have no effect whatsoever except to make ammunition so expensive that law-abiding citizens will be forced to turn to the black market for ammunition and will do nothing to solve crimes, which are commonly carried out with stolen firearms and ammunition.

I further support legalizing Tasers for public ownership in Hawaii. At the moment, defending your home means lethal violence in many cases. There is no middle ground. And even in cases where the victim successfully saves the life of him or herself, they face mandatory arrest. I am HR-218 certified, so I can legally carry concealed firearm. Within the past five or so years, I have been doing so much more frequently because crime is on the rise. There are thousands of retired Hawaii police officers who are not allowed to carry firearms after their retirement. Who better to act as the buffer between civilian victims in public and police officers but highly trained retired officers who prove their ability with firearms on an annual basis?

I have carried a concealed firearm for forty-eight years. I have never been in ANY incident, nor committed a crime. But if I saw a police officer down, I would go to his aid instantly. And I would be arrested for doing so. That makes no sense, Ma'am.

Please support the West Hawaii range and the freedom of all Americans to protect themselves.
