Title of Bill:

HB 2972, HD1, HSCR909-08 RELATING TO EDUCATION.

Purpose of Bill:

Creates the Facilities Alignment Commission to establish criteria for the selection of public schools to be constructed, expanded, consolidated, or closed; and recommend areas for new school construction, schools for expansion, consolidation, or closure. Requires the Board of Education to comply with these recommendations if the Legislature does not disapprove of them in their entirety. (HB2972 HD1)

Department's Position:

The Department of Education does not support this bill. Chapter 8-38 of the Hawaii Administrative Rules ("Consolidation of Schools") provides a procedure for evaluating schools for possible consolidation or closure. The commission created by this bill would perform the same functions, making it duplicative of existing mechanisms and the planning responsibilities of the department.

The bill directs the Board of Education to expand existing schools and build new schools as recommended by the commission. However, providing new facilities will continue to be based on the funding priorities of the Legislature.

The bill requires the department to prepare a facilities plan for each school by August 31, 2008. Given the likelihood that this bill would not be enacted before July 1, 2008, there would be insufficient time to prepare such a plan.

The recommendations of the proposed commission would also duplicate the work required by the 2007 Legislature to implement Act 245. The Act

requires developers of residential housing to pay impact fees for schools in areas designated as impact fee districts. The new districts' boundaries will be determined based on the same type of analysis required of the facilities alignment commission. The analysis is scheduled to be completed this fall for Board review and action.

Finally, we do not support this appropriation bill at this time due to Hawaii's impending fiscal austerity and priority for the current Board of Education's budget requests.

I am Jacqui Hoover, President of the Hawaii Leeward Planning Conference (HLPC), a member-based organization incorporated in 1974 whose seventy-five plus members are committed to sound planning, wise use of our resources, and effective government process.

As Hawaii faces changing demographics, we find ourselves bearing witness to a decline in overall student population statewide. This is occurring while we are simultaneously attempting to respond to the demand for new schools in high growth areas, and questioning how to handle existing and underutilized school facilities.

HLPC supports the intent of HB No. 2972, HD1 and the creation of "a facilities alignment commission the facilities alignment commission to revitalize school facilities by developing and submitting recommendations for areas for new school construction, schools for expansion, and schools for consolidation or closure." The bill further "allows the legislature to disapprove these recommendations only in their entirety. If no legislative disapproval occurs, requires the Board of Education to comply with these recommendations."

HLPC is concerned however, that the bill in its present form, does not provide a funding source to the Department of Education to implement the commission's recommendations. We urge you to consider (including and not limited to) recommendations for funding such as leveraging land value, authorization and implementation of mixed use for facilities, and creation of a public schools land trust.
