> IN STRONG SUPPORT OF HB 3004 Rights-of-Way to Expand Capacity

Charley's Taxi strongly supports HB 3004 to designate routes and rights-of-ways to address traffic congestion due to insufficient lane capacity on our state highways.

ROAD RATIONING = TRAFFIC CONGESTION

Hawaii is regularly vulnerable to natural disasters. Evacuation routes are woefully inadequate in coastal areas especially. Moreover, Hawaii can no longer ignore the challenges of congestion and capacity.

"One business at a time and one commuter at a time, congestion robs our nation of productivity and quality of life."

Federal Highway Administrator Rick Capka, USDOT, 12/05/05 [i]

Since 1990, only 2.23 freeway miles has been added on Oahu despite substantial increases in residential units in West Oahu in that same period.

Traffic congestion today on H-1 today [ii] shows a Volume-to-Capacity (V/C) Ratio of 1.15 on H-1, Level of Service (LOS) F, (to become V/C 1.85 LOS F in 2030 with rail.)

Every county in the state has experienced a drop in road miles to population since 1970:

1970 - 2000 POPULATION: ROADS, HIGHWAYS including unpaved roads

STATEWIDE: Population increased 57% (769.9 to 1211.5 = 441,600) Roads, Highways increased 19% (3584.7 to 4256.1 = 676.4 miles) 4.7mi/1000 population - 3.5mi/1000 population

KAUAI: Population increased 110% (27.9k to 58.5k = +30.600) Road/highway miles increased 28% (320.51m to 412.41m, net +91.89)

LATE TESTIMONY

11.5mi/1000 pop - 7mi/1000 pop

MAUI: Population increased 231% (38.7k to 128.2k = +89,500) Road/highway miles increased 19% (519.92m to 620.08m, net +100.16) 13.3mi/1000 pop - 4.8mi/1000 pop

HAWAII: Population increased 134% (63.5k to 148.7k = +85,200) Road/highway miles increased 8% (1380.3m to 1493.7m, net +113m) 21.6mi/1000 pop - 10.0mi/1000 pop

OAHU: Population increased 39% (630.5k to 876.2k = +245,700) Road/highways increased 28% (1212.2m to 1547.6m, net +335.4m) 1.9mi/1000pop - 1.8mi/1000 pop

The need for HB 3004 is obvious. It is HDOT's primary duty to preserve rights of way for future needs.

Carole, Honolulu resident, supports HB 3004, which requires DOT to identify all existing and any possible rights-of-way within each county that would facilitate the building of more lane miles and increase the carrying capacity of the highways within its jurisdiction. For example, the City's Alternatives Analysis Report said that the level of service was F (congestion) on H-1 in 2005 and projected a level of service of F on H-1 in 2030 with transit improvement. The State DOT has not suggested any improvements to H-1. They are not now in the business of building new highway lanes according to the State's 2007 Program Memorandum. Elevated lanes in existing rights-of way should be considered as a possible way to increase carrying capacity of highways. I understand that funds not available to design and construct these improvements at this time, but this should not be a criterion to identify possible solutions for this report. Funding would be considered after this report. Under the Bill Section 2, DOT should be require to solict ideas and comments from engineering firms and academy as well as the cooperation with the counties.
