Chair Sonson, Chair Evans and Committee Members:

I am Major General Bob Lee, Director of Civil Defense, State Department of Defense. I am providing written testimony in opposition to House Bill 3030.

House Bill 3030 clarifies that the Governor may not suspend statutes relating to wages and hours on public works projects unless a state of emergency is declared under the provisions of section 127-10.

From a State Civil Defense perspective, House Bill 3030 is not necessary. The proposed bill will limit the Governor's emergency powers by restricting her ability to take action when immediate action may be needed regardless of the cause of the emergency.

Statement of the Hawaii Carpenters Union on HB3030

The Hawaii Carpenters union is in support of HB 3030 and urges its passage.

The Bill simply clarifies that an emergency declared by the governor that may result in the suspension of Chapter 104, HRS, refers to an emergency as provided by section 127-10, HRS. It does not change Chapter 127. It does not change the intent of section 104-32.

Currently Chapter 104 is lacking a statutory reference for a state of emergency declared by the governor. The clarification should help prevent an erroneous suspension of prevailing wages on public works projects based on a non-specific usage of "emergency".
