

# Testimony Strongly Supporting HB 3052, "Relating To Tobacco"

The American Heart Association strongly supports HB 3052.

Tobacco remains the most deadly consumer product on the market. It is also the most addictive product on the consumer market. Most of its users begin their addiction prior to age 18, despite it being illegal to sell tobacco products to minors.

Until the Hawaii legislature passed Act 151 in 2005, there were few deterents to retailers who chose to ignore the law, or were lax in training their employees to refrain from selling to minors. Act 151 provides that deterent.

Hawaii youth smoking rates have dropped by half over the last decade. Much of that success can be attributed to the comprehensive approach that has been made through the Hawaii State Legislature to address that issue. Requiring tobacco retailers to be licensed, and including in the law the threat of loss of that license for repeated illegal sales of tobacco products to minors, are key parts of a proven, comprehensive approach to reducing youth smoking.

The American Heart Association strongly urges legislators to keep this important law on the books by passing HB 3052.




We would request that HB3052 be passed on for additional hearings by the Judiciary and Finance Committees.
