FULL SUPPORT OF HCR111 & HR 93: Relating to Public Housing Incentives

Aloha Chair and members of the committee:

My name is Kanani Kaaiawahia Bulawan. Before I start I'd like to point out that among

other positions I represent, I am a staff member of Rep. Karen Awana; however, my

testimony here this morning is based on my own opinions and experience. With that

said, I will now state my reason for testifying in Full Support of HCR111 & HR 93relating to

Public Housing Creating Incentives for tenants to Transition to permanent housing.

First as a tenant of public housing and a private citizen, you can become very comfortable with living in "affordability" and not be accountable for the changes in your family's circumstances because it would be the "Housing's" responsibility to adjust to your circumstance. In our case, I'm glad that the management at the time was very supportive by assuring us the income we had was enough to afford rent and to prepare for other housing options. Today I'm proud to say that my family was given the opportunity to find permanent housing while we were living in public housing. As a private citizen I can see why people who live in public housing sense they "have it made" and have no reason to move out of public housing. Consider the process as it is today. A family lives in housing pays a minimum of 30% of their annual income towards rent. If this income changes, the rent changes to the minimum of \$0.00 and depending on what housing site you are living in you may also be credited an energy allowance. Moreover if you lose your income there is no requirement for you to replace it in a timely manner. In addition to this the family size changes, the housing will relocate you to another unit that will best fit your family size. I ask why you would want to move. The housing department reports rent collections are falling because among other reasons, families aren't receiving income and therefore must be 100% supplemented.

Second as the director of a non-profit organization that primarily focused on human services and housing issues, it is very frustrating to know that there are clear

distinct groups of people that are in need of public housing and cannot attain it

because of a group of other people who believe that public housing it their permanent home and see no way to leave that settling. As I recall the intention and

purpose of public housing was to allow a family to have safe and affordable housing

while being able to seek permanent housing via homeownership or other "specialized" housing. If this is the intent then the current management and operations of housing is failing. I understand this measure will cause more work. I

also understand there is a huge and unmanaged waitlist and more important I

understand the need for housing units to address the people in homeless shelters.

Consider this process if we make some changes today. A family is unsheltered and

moves into a homeless program. Gets the initial services for preparation to transition. Moves into transitional housing for a maximum of 2 years then be able

to transition into affordable housing for another period of time to assure that

permanent housing is achieve. The period of affordable housing is where public

housing places a role. The period of stay may last up to 5 years assuring that a plan

is in place that would be monitored through the management review as like a service

plan that is monitored by the management agency. These are only a few of the

suggestions to create incentives. I'm sure there are lots more that can be considered

and I would encourage that HPHA start the process for planning the implementation of these types of incentives. And, there will always be a special

group of people who will need to be in public housing for a permanent period, i.e.

elderly and disable in which "special supportive" housing is necessary. Our community has many needs and challenges. The bill identifies the concerns and

solutions in addressing the barriers to assuring we have a healthier community and

thereby reducing the need for continued government interventions. More strongly the bill

demands that public housing revisit their purpose and implement the changes that will

motivate current tenants to transition into permanent housing so that others waiting can

have the same opportunities.
